for the financial year ending on the 30th day of
September, 2026

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Appropriation Short title
(Financial Year 2026) Act, 2025.

Issue from the
Consolidated Fund
authorised

2. (1) The issue from the Consolidated Fund of the sum of Fifty Thousand, Four Hundred and Five Million, Six Hundred and Ninety Five Thousand, Two Hundred and Ninety Three Dollars (\$50,405,695,293) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2026, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of Fifty Thousand, Four Hundred and Five Million, Six Hundred and Ninety Five Thousand, Two Hundred and Ninety Three Dollars (\$50,405,695,293) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2026.

Commencement

3. This Act is deemed to have come into force on the 1st day of October, 2025.

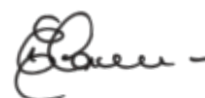

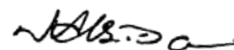
