PUBLIC STATEMENT OF THE TRINIDAD AND TOBAGO BLIND WELFARE ASSOCIATION (TTBWA)

In accordance with the chapter 7, 8 and 9 of the Freedom of Information Act (FOIA) the public has a legal right to access information and documents regarding the operations of the Trinidad and Tobago Blind Welfare Association (TTBWA). This comprises of the structure and functions of the TTBWA along with a listing of documents in the possession of the Association. The TTBWA also specifies which documents are available to the public.

The FOIA gives members of the public:

- 1. A legal right for each person to access information held by the Trinidad and Tobago Blind Welfare Association.
- 2. A legal right for each person to have official information relating to him/her amended where it is incomplete, incorrect or misleading;
- 3. A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA;
- 4. A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA

STATEMENTS UNDER SECTION 7 OF THE ACT

Section 7 (1) (a) (i)

The Trinidad and Tobago Blind Welfare Association is a nonprofit, voluntary, rehabilitation organization established via statue that has a commitment to assist persons who are blind and visually impaired in coping with the problems that result from limited vision, failing vision and total blindness. The Association has been in existence since 1914 and was incorporated by an Act of Parliament in 1947 (Act 14 of 1947) and amended in 1953.

The Association's operational frame work is in its vision and mission which is as follows:

VISION:

A world that is inclusive, diverse and equitable for all.

MISSION

To inspire persons who are blind, to exceed expectations through progressive networking with all stakeholders, to add value to the global community through advocacy and inclusion, creating a diverse and equitable society.

CORPORATE INFORMATION

There are four branches of the TTBWA which are as follows;

The TTBWA has ninety (90) employees. Approximately Sixty-four (64) percent are blind/visually impaired; while thirty-six percent are sighted. The TTBWA is headed by a Council of 18 members. There are twelve (12) elected members and six (6) government representatives. The Executive Officer of the Association is also the Secretary to the Council. Elections for new board members are held every two years at the Association's Annual General Meeting. These elections are presided over by personnel who have experience working with Trinidad and Tobago Elections and Boundaries Commission. The Government representatives on the Council are selected from various government ministries upon request from the TTBWA to the President of the Republic of Trinidad and Tobago which is then approved by Cabinet.



- 1. Applicants are required to fill out the Request for Information form clearly specifying the document they wish to view as listed by the TTBWA in the Freedom of Information Statement. This form can be obtained at all TTBWA Branches.
- 2. The form must be filled out correctly by entering the relevant information into the form fields and signature affixed.
- 3. Accurate contact information must be submitted to facilitate any clarification that has to be sorted from the applicants. The TTBWA will not be responsible for meeting the request of persons who submit incorrect contact information.
- 4. The TTBWA has the right to refuse to meet the request of persons applying to view documents under the FOIA if the applicants have not filled out the revenant data required. Applicants have the right to challenge any refusal of request via the use of a query form which will be provided by the TTBWA.

Time Allowed:

Applicants will be notified within thirty days after the date that their request was made whether their request was approved or denied.

Applicants whose requests are refused will be notified by the designated Officer in writing of the reasons for refusal. A consultation will be done with applicant informing them of ways of recourse.

Fees and Charges

Cost of documents will be determined based on the request.
