IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under section 45(2), of the Spirits and Spirit Compounds Act, Chap. 87:54. I, Riad Juman, Acting Comptroller of Customs and Excise, do hereby appoint the place specified in the Schedule hereunder to be an Excise Warehouse for the storage of Margarita RTD Cocktails, Pepa RTD Cocktails, Angostura Chill, WO Spritz, 420, Puncheon Punch and Str8 Vybz by Caribbean Bottlers Trinidad and Tobago Limited on premises situated at Churchill Roosevelt Highway, Streatham Lodge, Tunapuna for local consumption or export.

SCHEDULE

An enclosed square area which measures 13.56 meters in length running east to west. On the northern side measures 13.40 meters running north to south and has a sloping roof which measures 10.67 meters at the highest point. The total area measures 183.06 square meters. The shelving occupies to approximately half of the room and runs from east to west with no spaces in between but is occupied by one whole shelving system. The building is constructed of concrete flooring and the shelving is made of steel and steel cross beams. The room is constructed of three (3) concrete walls and the wall on the northern side is made up of one part concrete walls and one part steel gratings. An emergency exit is situated at the northern eastern corner of the room. There are two doors located on the western side of the room, one is a pedestrian door and the other is a forklift entrance door which has a shutter door.

It is bounded on the south by the Churchill Roosevelt Highway and on the north by Tunapuna Pubic Cemetery, on the east by Trinidad Concrete Products on the West by a Road Reserve.

Whereas:
