In compliance with Sections 7, 8 and 9 of the Freedom of Information Act, CHAP 22:02
PUBLISHED WITH THE APPROVAL OF THE MINISTER OF FINANCE

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, Chapter 22:02 ("FOIA") the National Insurance Board Of Trinidad And Tobago (NIBTT) is required by law to publish the following statement, which lists the documents that are generally available to the public.

The FOIA gives members of the public:

1. A legal right for each person to access information held by the NIBTT;
2. A legal right for each person to have official information relating to him/her amended where it is incomplete, incorrect or misleading;
3. A legal right to obtain reasons for adverse decisions made regarding applicant's request for information under the FOIA; and
4. Upon receipt of a Notice of Refusal, a legal right to complain in writing to the Ombudsman and to apply to the High Court for Judicial Review of decisions made under the FOIA.

The following information satisfies the requirements of the FOIA and the NIBTT publishes the following statement as approved by the Minister of Finance.

SECTION 7 STATEMENTS

Section 7 (1) (a) (i)
Function and Structure of the NIBTT

The NIBTT is a body corporate established by virtue of the National Insurance Act Chapter 32:01 (the Act).

The NIBTT is governed by an eleven-member tripartite Board with equal representation by Government, Business and Labour, an independent

Chairman, and the Executive Director as an ex-officio member. Directors are appointed for a period of not more than two years but may be reappointed. It is the duty of the Board to operate and manage the system of National Insurance established by the Act.

The Act vests the NIBTT with powers to:

- establish local offices throughout Trinidad and Tobago;
- invest in securities as set out in the First Schedule of the Act;
- Issue registration certificates or cards in respect of employers or employed persons
- register employers or reject or revoke the registration of any person purporting to be an employer or an insured person under the Act in prescribed circumstances;
- furnish or disclose any information pertaining to the National Insurance Contribution records of any insured person under this Act to any Governmental Department, Agency or Statutory Body;
- determine claims and questions arising under or in connection with the Act;
- authorize the manner for the payment of contributions;
- postpone the payment of contributions in prescribed circumstances;
- refer to medical referees any medical question relating to an insured person in respect of certain claims
- request such evidence as it considers necessary to support any claim to benefit;
- request that an insured person in receipt of or entitled to benefit submit himself for a medical examination in Trinidad and Tobago;
- request proof of life or medical status of a beneficiary or recipient of benefit under the Act or Regulations thereunder;

- suspend, cease or reinstate benefits payments in certain circumstances;
- disqualify a person from receiving certain benefits in prescribed circumstances

The NIBTT reports to Parliament through the Ministry of Finance.

Staffing and structure

The NIBTT has in its employ six hundred and sixteen staff members, including an Executive Director. The Executive Director is the chief executive officer of the NIBTT leading the management team and is responsible for carrying out the decisions of the Board.

The NIBTT is structured into eight Business Units of which seven directly report to two Chief Operating Officers, seven departments with specific reporting lines to the Executive Director, the Chief Operating Officers or the Board; two Chief Operating Officers and the Executive Director's Office. Both Chief Operating Officers report directly to the Executive Director, each Business Unit is headed by an Executive Manager and each department headed by a Senior Manager as follows:

Business Units/Departments reporting to the Chief Operating Officer Business Services

- Insurance Operations
- Investments
- Planning, Policy and Actuarial Services

Business Units/Departments reporting to the Chief Operating Officer Corporate Services

- Finance and Administration
- Legal Services
 - Appeals
- Technology
 - Records Department
- Human Resources
- Procurement

Three departments reporting to the Executive Director:

- Corporate Projects
- Corporate Communications
- Investigations and Controls

Three departments reporting functionally to the Board and administratively to the Executive Director:

- Corporate Secretariat
- Internal Audit Department
- Risk Business Unit

1. **Executive Director.** The Executive Director has overall responsibility for the efficient operation of all line functions and is accountable for strategic management. The Executive Director ensures that approved strategies, plans, policies and systems are implemented. The Executive Director reports to the Board of Directors and leads strategic stakeholder engagement.

2. **Corporate Secretary.** The Corporate Secretary is accountable to the Board through the Chairman for all matters relating to corporate governance and the organisation's corporate secretarial duties. The Corporate Secretariat Unit serves as the secretariat for Board meetings and meetings of the sub-committees of the Board as well as maintains and implements a corporate governance framework for NIBTT. The Corporate Secretary keeps and maintains minutes of the Board/Board committees and controls the security and application of the corporate seal, and maintains the corporate books and records.

3. **Internal Audit Department.** The Internal Audit department is responsible for providing the Board and Management with

independent, objective assurance and consulting services in such areas as controls, risk management and governance processes designed to add value and improve NIBTT's operations.

4. **Risk Business Unit.** The Risk Business Unit is responsible for enterprise risk, business continuity and organisational compliance. This Business Unit guides the process by which business risks are identified, assessed, managed, and monitored across the NIBTT.

5. **Corporate Projects Department.** The Corporate Projects Department is responsible for the planning, executing, monitoring and reporting of projects or business initiatives in accordance with strategic and operational plan and approved budgets.

6. **Corporate Communications Department.** The National Insurance Board of Trinidad and Tobago's Corporate Communications Department oversees strategic marketing, reputation management, brand development and management, public relations, event management, communications and digital strategy for the NIBTT.

7. **Investigations and Controls Department.** The Investigations and Controls Department is responsible for the implementation of preventative, detective and response mechanisms to treat with internal/external fraud, whether actual or suspected.

8. **Insurance Operations Business Unit.** The Insurance Operations Business Unit is responsible for the registration of employers and employees, employer audits, contribution

income collection and claims administration in respect of 23 national insurance benefits to insured persons and their dependants based on legislative requirements as prescribed by the Act and the Regulations thereto.

9. Investments Business Unit.

The Investment Business Unit is responsible for managing the investment portfolio of the NIBTT in a prudent manner to maximize returns in accordance with the Board's strategic objectives, risk appetite, policies and procedures, statutory requirements, generally accepted industry norms and established rules of professional conduct and practice.

10. Planning, Policy and Actuarial Services Business Unit.

The Policy, Planning and Actuarial Services Business Unit is responsible for evaluating and monitoring the performance of the National Insurance Fund through the conduct of actuarial reviews, organisation policy and procedure development and implementation, managing and reporting on key operational and strategic planning activities and socio-economic research for the organisation.

11. Finance And Administration Business Unit.

The Finance and Administration Business Unit is responsible for designing and implementing systems and controls to ensure the effective and efficient use of the organisations financial resources. This includes providing strategic advice to executives with oversight over accounting, finance, benefit payment and settlement of investment transactions. Responsibilities also include the administration of payroll, maintenance of the financial reporting statements, including producing and managing the

budget and the preparation of financial statements for the Board. The Finance and Administration Business Unit is also responsible for the Facilities, Services and Security Department.

12. Legal Services Business Unit.

The Legal Services Business Unit provides all legal services to the organisation including legal advisory services, litigation management and contracting. This department also manages the NIBTT's appeals process in accordance with the National Insurance (Appeals) Regulations made pursuant to the National Insurance Act.

13. Human Resources Business Unit.

The Human Resources Business Unit is responsible for recruitment and selection, organizational development, succession planning, training and development, employee engagement and management of industrial relations and the employee benefits.

14. Technology Business Unit.

The Technology Business Unit plans, implements and manages technology within the NIBTT in alignment with strategic objectives. The Technology Business Unit performs three high level functions in the areas of IT governance, ICT service availability and maintenance and support.

15. Records Department

The Records Department is responsible for maintaining records management systems that meet legal requirements for record retention, protection of privacy and information dissemination. This includes activities associated with centralized data capture, document imaging and error correction of contribution data submitted by the employer population.

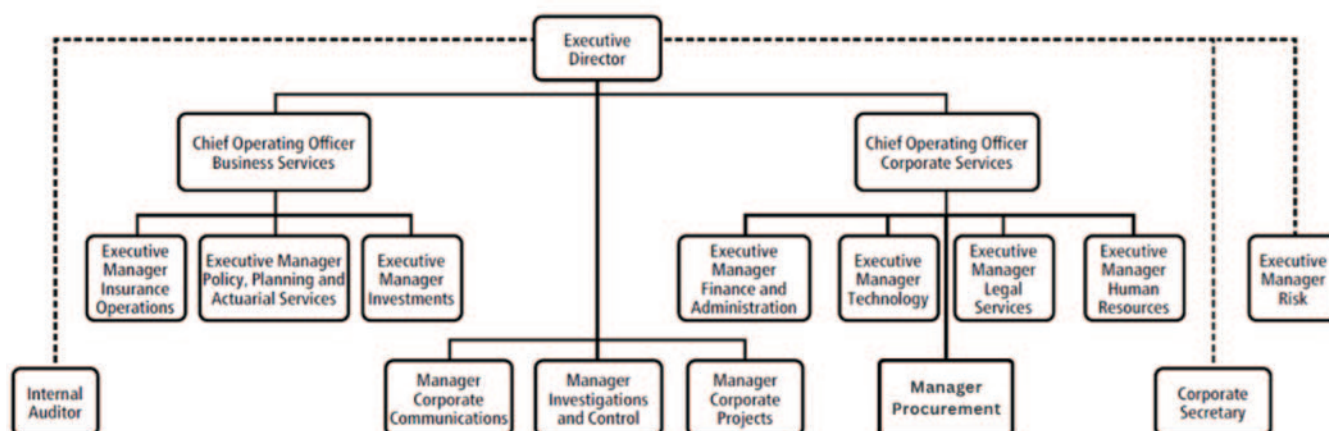
EFFECTS OF SCOPE OF BUSINESS ON MEMBERS OF THE PUBLIC:

• Details to be included in the request

Applicants should provide details that will allow for ready identification and location of requested records. The relevant information that must be provided to the NIBTT includes:

- Name of applicant (full name preferred)
- Contact information
- Information requested and format to provide the information
- Date of request
- Signature of applicant

The completed form may be:

- a. Hand delivered to the NIBTT
- b. Mailed to the NIBTT, or
- c. Emailed to sbaboolal@nibtt.net

Requests not handled under the FOIA

• A request under the FOIA will not be processed to the extent that it asks for information, which is readily available to the public, (for example brochures, pamphlets, reports etc.) either from the NIBTT website, a publicly accessible register or from another public authority.

Responding to requests

• Retrieving documents

The NIBTT is required to furnish copies of documents only when they are in our possession, or we can retrieve them from our records.

• Furnishing documents

An applicant is entitled to copies of information in our possession. We are required to furnish one copy of a document. If we cannot make a legible copy of a document to be released, we may not attempt to construct it. Instead, we will furnish the best copy possible and note the quality in our reply. Please note that the NIBTT is not compelled to do the following:

- (a) Create new documents
- (b) Perform research for the applicant

Time Limits

• General

We will determine whether to grant your request for access to information as soon as practicable but no later than thirty calendar days as required by Section 15 of the FOIA. If a decision is taken to grant access to the information requested, you will be provided with copies, or if you so request, permitted to inspect the document/s.

IN COMPLIANCE WITH SECTIONS 7, 8 AND 9 OF THE FREEDOM OF INFORMATION ACT (FOIA) 1999

In accordance with Sections 7, 8, and 9 of the Freedom of Information Act (FOIA) 1999, the Institute of Marine Affairs (IMA) is required to publish a statement setting out certain information for the benefit of the public.

The Act gives members of the public:

1. A legal right for each person to access information held by the IMA;
2. A legal right for each person to have official information relating to him/her amended where it is incomplete, incorrect or misleading;
3. A legal right to obtain reasons for adverse decisions made regarding applicant's request for information under the FOI Act; and
4. A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOI Act.

Section 7 (1) (a) (i)

PURPOSE AND FUNCTIONS OF THE INSTITUTE OF MARINE AFFAIRS (IMA)

The IMA is a statutory body established by Act of Parliament (Chap. 37:01 of the Revised Laws of the Republic of Trinidad and Tobago, as amended by Act No. of 1990). Established following negotiations for an Agreement signed in 1974 between the Government of Trinidad and Tobago and the United Nations, through its Executing Agency, the United Nations Development Programme (UNDP), the IMA has been in operation since 1978. In 1990, legislation was amended by Act No. 13 to emphasise and underscore the Institute's regional role and to expand its scope to include marine and other related areas of the environments. It is one of the oldest multi-disciplinary marine research organisations in the Caribbean Community (CARICOM) established to conduct inter-disciplinary studies.

Functions

The functions of the IMA, which are discharged with the assistance of research and administrative staff in furtherance of its mandate, are to:

- a. Conduct research and development on the marine and related resources of Trinidad and Tobago, the Caribbean and adjacent regions.
- b. Implement projects and programmes related to the marine environment, both locally and regionally.
- c. Promote public awareness and knowledge through its information centre.
- d. Conduct research and development on the marine environment and other areas that impact upon the environment of Trinidad and Tobago, and adjacent regions.
- e. Study multiple uses of the sea and coastal zones, resources and use potential in Trinidad and Tobago, and adjacent regions and to evaluate and promote such studies to minimise conflicts which may result from such uses.
- f. Establish at the IMA, an Information Centre for collection and dissemination of information on economic, social, technological, environmental

and legal developments in marine and coastal zones of the Caribbean and adjacent regions.

- g. Provide information and advice to the government in its formulation of policies relating to the marine and other related aspects of the environment.
- h. Respond to technical enquiries and questions by policy-making organs of the Government, private sector organisations and individuals.
- i. Organise training courses and projects that foster and encourage regional and international collaboration in sustainable use of the marine and related environment.
- j. Advise development and optimum utilisation of the marine and coastal resources potential of Trinidad and Tobago.
- k. Take necessary action or expedite activities for proper performance of its functions.

"To conduct and foster research and provide advice to support the sustainable management of the coastal and marine areas and resources of Trinidad and Tobago."

RESPONSIBILITIES OF INTERNAL DIVISIONS AND UNITS (DIRECTORATE)

BOARD OF GOVERNORS

Established since 1990 by an Act of Parliament No. 13 of 1990, the Board of Governors is the policy-making organ of the Institute, responsible for the proper administration which includes reviewing and approving research work programmes, approving annual budgets and annual reports and securing finances for the IMA to attain its deliverables.

DIRECTORATE

The Directorate assists with policy formulation through its advice to Government ministries and agencies based on applied and scientific research while executing tenets of national policy. The main function of the Directorate is to provide strategic guidance and direction to the research programmes and support departments to ensure that the Institute achieves its research vision, mission, short-term and long-term goals. It comprises the Corporate Secretary/ Legal Advisor and Internal Audit.

- The Internal Audit is charged with the responsibility of ensuring that the system of accounting, as prescribed by the Ministry of Finance, is established, implemented and maintained in the IMA. The Unit's primary functions are to safeguard the assets of the Institute while ensuring that all financial records are complete and accurate

RESEARCH PROGRAMMES

- **Biodiversity and Ecology Research Programme** - conducts fundamental and applied research on coastal ecosystems such as wetlands (mangroves and seagrasses), coral reefs, benthic communities and invasive or alien marine species. The Programme also includes the following research areas: taxonomy, restoration ecology and marine protected areas. The data generated from the research is used to inform management plans and policies toward conserving biodiversity.
- **Environmental Quality Research Programme** - conducts research on the water and sediment quality of the coastal and marine environments. This includes monitoring of pollutants such as nutrients, heavy metals, bacteria and hydrocarbons. Data generated provides information on the effectiveness of pollution reduction strategies and mitigation control and assists in the interpretation of pollutant effects by showing links between different forms of pollution to sources, bioaccumulation, eutrophication studies and pollution transport. The Programme is also charged with responding to environmental incidents such as oil and chemical spills.
- **Fisheries and Aquaculture Research Programme** - comprises two principal thematic research areas: 1- Fisheries Biology with a focus on fish age and growth studies and reproductive biology; and 2 - Aquaculture - research has transitioned from culturing of freshwater species to marine species and is geared towards developing the technology, and creating a demonstration facility at the IMA for the culture

of marine organisms (mariculture). The overarching aim is to develop working business models for the controlled and consistent production of various marine aquatic species (fish and shellfish), with the expectation that the output would create investment opportunities for the private sector, and support sustainable coastal livelihood. The Programme also supports research in marine turtle conservation and responds to environmental incidents such as fish kills.

- **Oceanography and Coastal Processes Research Programme** - conducts research in oceanography and hydrography; sedimentology; coastal dynamics; and, coastal engineering. The data generated from this research programme is used to inform management plans, environmental policies and provide advice on development plans at the macro level.
- **Marine Policy and Governance** - conducts research on local, regional and international environmental policies and legislation related to the marine environment including multi-lateral environmental agreement, and makes policy recommendation based on research findings.

GEOGRAPHIC INFORMATION SYSTEMS (GIS) UNIT

The GIS Unit provides spatial management and support for the development of research ideas through spatial data and products, including the creation of web-based systems to increase the availability, presentation and usefulness of such data and products to general users. It carries out GIS analysis and Remote Sensing for various projects and programmes of the Institute

HUMAN RESOURCES DEPARTMENT

The principal objective of the Human Resources Department is to provide timely and efficient human resources support to the IMA through its Manager and administrative support services.

INFORMATION CENTRE

The Information Centre (IC) supports the Research Programmes of the IMA through the implementation of innovative public education and communication strategies. The Centre comprises a Library Unit which is responsible for organising and maintaining a current information service that is primarily relevant to the research work conducted at the Institute and is also available for use by the public.

INFORMATION TECHNOLOGY DEPARTMENT

The Department has overall responsibility to provide and manage the information systems and information technology portfolios of the IMA, as well as providing the necessary Information Technology (IT) support as required.

FINANCE AND ADMINISTRATIVE DEPARTMENT

This Department supports the attainment of the organisation's financial and strategic objectives by:

- Safeguarding the Institute's financial & other assets;

b. Addressing Requests:

To facilitate prompt handling of the request, it should be addressed to the Designated Officer of the IMA (see Section 7 (1) (a) (vi)).

c. Details in the Request

Applicants should provide details that will allow for ready identification and location of the records that are being requested. If insufficient information is provided, clarification will be sought from the applicant. If an applicant is unsure how to write the request or what details to include, they are advised to communicate with the IMA's Designated Officer.

d. Requests not handled under the FOIA

A request under the FOI Act will not be processed to the extent that it asks for information, which is readily available to the public, either from the IMA or from another public authority, e.g. brochures, pamphlets, reports etc.

Responding to Applicant's Request

e. Retrieving Documents

The IMA is required to furnish copies of documents only when they are in its possession or can be retrieved from storage.

f. Furnishing Documents

An applicant is entitled to copies of information the IMA has in its possession, custody or power. The IMA is required to furnish only one copy of a document. If a legible copy of a document cannot be released, the IMA may not attempt to reconstruct it. Instead, the IMA will furnish the best copy possible and note its quality in its reply. Please note the IMA is not compelled to do the following:

- i. Create new documents. For example, the IMA is not required to write a new programme so that a computer will print information in the format the applicant desires.
- ii. Perform research for the applicant.

Time Limits

g. General

The FOI Act sets a time limit of thirty (30) calendar days for determination of a request for access to documents. The IMA is required to meet this deadline by granting the request for access to information as soon as practicable but no later than 30 days, as required by Section 15 of the FOI Act. If a decision is taken to grant access to the information requested, the applicant will be permitted to inspect the documents and/or be provided with copies. Should the IMA fail to meet the deadline, the FOI Act gives the applicant the right to proceed as though the request has been denied. If it appears that processing the request may take longer than the statutory limit, the IMA would acknowledge the request and advise the applicant of its status. Since there is a possibility that requests may be incorrectly addressed or misdirected, the applicant may wish to call or write to confirm that the IMA has received the request and to ascertain its status.

h. Time Allowed

The IMA determines whether to grant your request for access to information as soon as practicable but no later than 30 days as required by Section 15 of the FOI Act. If a decision is taken to grant access to the information requested, you will be permitted to inspect the documents and/or be provided with copies.

i. Fees and Charges

Section 17(1) stipulates that no fee shall be charged by a public authority for the making of a request for access to an official document. However, where access to an official document is to be given in the form of printed copies or copies in some other form, such as a tape, disk, film or other material, the applicant will be required to pay the prescribed fee incurred by the duplication of the said material. Similarly, where documents in the public domain are made available to a member of the public, the IMA may charge duplication fees in accordance with its normal reprographics policy.
