ORDER

Made by the Commissioner of Police under Section 68(1) of the MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (TOBAGO CARNIVAL) ORDER, 2025

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Tobago Carnival) Order, 2025.

PART I

SCARBOROUGH

Division 1-Duration

2. This Order shall have effect on-

Duration

- (a) Saturday 25th October, 2025—
 - (i) from 3.00 a.m. to 11.00 a.m.; and
 - (ii) from 5.00 p.m. to 2.00 a.m. on Sunday 26th October, 2025; and
- (b) Sunday 26th October, 2025 from 9.00 a.m. to midnight.

Division 2-Vehicular Traffic and Parking

3. A driver of motor vehicle shall not park or drive on the following Vehicular traffic and roads or in the following areasparking prohibited

(a) Shaw Park Cultural Complex Car Park;

- (b) Comfort Inn and Suites Car Park;
- (c) South from the Wilson Road Traffic Light to the Wilson Road and Calypso Rose Boulevard Junction;
- (d) Darrell Spring Road from the Claude Noel Highway, west to Darrell Spring and Wilson Road Intersection;
- (e) Gardenside Street;
- (f) Dutch Fort Street junction;
- (g) Royal Castle, front entrance on Calypso Rose Boulevard;
- (h) Post Office Road;

- (i) Waterfront Pharmacy, Wilson Road;
- (j) the Port of Scarborough, in the vicinity of Dutch Fort Street;
- (k) Sangster's Hill Road;
- (l) the road parallel to Calypso Rose Boulevard along the Scarborough Waterfront to which the public are granted access, commonly referred to as "The Esplanade";
- (m) the TLH Building compound on the Calypso Rose Boulevard;
- (n) the Taxi Co-operation compound on the Calypso Rose Boulevard;
- (o) Smithfield Road No. 1;
- (p) Smithfield Road No. 2;
- (q) Nelson's Bookstore compound on the Calypso Rose Boulevard;
- (r) Breeze Hall Road; and
- (s) Richard's Hardware compound on the Calypso Rose Boulevard.

Parking prohibited

- 4. A driver of a motor vehicle shall not park—
 - (a) in the Market Square Car Park;
 - (b) in the Old First Citizens Bank Car Park situated on Carrington Street;
 - (c) on Wilson Road, between Carrington Street and the Claude Noel Highway;
 - (d) on the Claude Noel Highway, in the vicinity of Wilson Road;
 - (e) on Orange Hill Road, Calypso Rose Boulevard and Milford Road Extension, also known as "Crusoe Bypass Road", in the vicinity of Yats Marketing;
 - (f) on Gardenside Street; and
 - (g) on Northside Connector Road.

Division 3-The Parade

Vehicular traffic prohibited

- 5. (1) A driver of a motor vehicle shall not proceed along—
 - (a) Calypso Rose Boulevard, Scarborough, to the Scarborough Waterfront, including the roundabout in the vicinity of Crusoe Bypass Road; and

(b) the Claude Noel Highway, from the Orange Hill traffic lights to Wilson Road traffic lights.

6. (1) This Part has effect—

Mas and Coventional

- (a) for J'Ouvert celebrations, from 3.00 a.m. to 11 a.m. on Traditional Saturday 25th October, 2025;
- (b) for Night Mas and Pan and Powder, from 5.00 p.m. on Saturday 25th October, 2025, to 2.00 a.m. on Sunday 26th October, 2025; and
- (c) for Traditional Mas and Conventional Mas, from 9.00 a.m. to midnight on Sunday 26th October, 2025.
- (2) Bands shall assemble as follows:
 - (a) for J'Ouvert and Conventional Mas, on Calypso Rose Boulevard, from Comfort Inn and Suites along Crusoe Bypass Road and then proceed north along Orange Hill Road onto the parade route; and
 - (b) for Traditional Mas and Night Mas, on Calypso Rose Boulevard in the vicinity of Yats Marketing, then, proceed south along Orange Hill Road to the parade route continuing east along Calypso Rose Boulevard, Scarborough.
- (3) The parade route for both J'Ouvert and Conventional Mas bands shall commence in the vicinity of Comfort Inn and Suites and proceed north along Orange Hill Road to the traffic lights at the Claude Noel Highway-Orange Hill Road junction, then proceed east along the Claude Noel Highway to the traffic lights at Wilson Road and Plymouth Road intersection, then turn south onto Wilson Road and continue south along Wilson Road, to end at the Scarborough Waterfront.
- (4) The parade route for Traditional Mas and Night Mas bands shall commence on Orange Hill Road in the vicinity of Yats Marketing, then proceed along Carrington Street north onto Gardenside Street, west along Post Office Street and south onto Wilson Road to end at the Shaw Park Complex.
 - 7. The temporary relocations of taxi stands are as follows:

Taxi stands

(a) West End Taxis plying routes from Scarborough to Western districts shall park on Plymouth Road in the vicinity of Pump Mill Road junction, facing north; and

(b) taxis plying routes from Scarborough to Windward and Northern districts shall park on the northern shoulder of the Claude Noel Highway, east of the Claude Noel Highway-Plymouth Road junction, facing east.

PART II

GENERAL

Emergency routes to Scarborough General Hospital

- 8. In case of an emergency, all emergency vehicles shall proceed—
 - (a) from the west, along the Claude Noel Highway, turn north at the traffic lights at Lambeau-Signal Hill Road intersection, onto the Signal Hill Connector Road, then east onto the Signal Hill Main Road and southeast onto the Old Government Farm Road to the Scarborough General Hospital;
 - (b) from the east, along the Claude Noel Highway, turn north at the Plymouth Road and Wilson Road intersection, then west onto Spring Garden Trace, continuing west along Spring Garden Road, north onto Spring Garden-Mt. Marie Road Extension, west onto Orange Hill Road in the vicinity of the Spring Garden Moravian Church, continuing across the bridge onto Signal Hill Main Road, and then turn southeast onto the Old Government Farm Road to the Scarborough General Hospital.

Access to prohibited routes

9. Notwithstanding clauses 3 and 4, a driver of a motor vehicle may traverse prohibited routes at the discretion of and in accordance with the directions of a police officer who is on duty.

Removal and impounding of vehicles unlawfully parked 10. Without prejudice to any liability incurred by the commission of a traffic violation, a motor vehicle found parked in contravention of this Order may be removed, impounded and dealt with in accordance with sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
