## REPUBLIC OF TRINIDAD AND TOBAGO

The Emergency Powers Regulations, 2025

## ORDER

Made by the Minister of Homeland Security in accordance with paragraph 2 of the Schedule to the Emergency Powers Regulations, 2025

## DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to RICARDO MARK FELIX, of Light Pole No. 2, No. 17 Cumuto Main Road, Cumuto, and also of P 2–3, 1st Street, Sparrow Drive, Petit Valley and also of 1st Street, Sparrow Drive, Petit Valley, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago.

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, hereby order that the said RICARDO MARK FELIX, of Light Pole No. 2, No. 17 Cumuto Main Road, Cumuto, and also of P 2–3, 1st Street, Sparrow Drive, Petit Valley and also of 1st Street, Sparrow Drive, Petit Valley,

shall be detained in the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said RICARDO MARK FELIX, of Light Pole No. 2, No. 17 Cumuto Main Road, Cumuto, and also of P 2–3, 1st Street, Sparrow Drive, Petit Valley and also of 1st Street, Sparrow Drive, Petit Valley shall be detained and so kept in lawful custody.

Take Notice that the grounds upon which this detention order is made are as follows:

The detainee, RICARDO MARK FELIX, has been credibly identified as an active member of the Dibe Hill Gang, which is an Organised Crime Group ('OCG') within the legal definition of the Anti-Gang Act, 2021. The OCG is responsible for murders, robberies, extortion, kidnappings, and firearms trafficking. The OCG possesses a cache of high-powered firearms. The detainee and others are conspiring to imminently commit kidnappings for ransom to raise money for legal fees and bail of their associates. The OCG possesses a cache of high-powered and modified firearms which are intended for use in the planned kidnappings in public spaces.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety
