## **ORDER**

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (NATIONAL DAY OF REMEMBRANCE) ORDER, 2025

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (National Day of Remembrance) Order, 2025.
- 2. This Order shall have effect from 5.00 a.m. to 1.00 p.m. on Duration Sunday 9th November, 2025.
  - 3. A driver shall not park a motor vehicle on—

Parking prohibited

- (a) Queen's Park West, between Queen's Park East and Chancery Lane;
- (b) Queen's Park East;
- (c) Keate Street, between Charlotte Street and Chancery Lane;
- (d) Gordon Street, between Charlotte Street and Dundonald Street;
- (e) Frederick Street, between Gordon Street and Queen's Park West;
- (f) Abercromby Street, between Gordon Street and Keate Street;
- (g) Pembroke Street, between Gordon Street and Keate Street;
- (h) New Street, between Pembroke Street and Charlotte Street;
- (i) Dundonald Street, between Queen's Park West and New Street;
- (j) Albion Street, between Chancery Lane and Dundonald Street;
- (k) Chancery Lane;

- (1) Jerningham Avenue, between Queen's Park East and Norfolk Street; and
- (m) the part of the road to which the public are granted access to enter the Queen's Park Savannah, proceeding north from the corner of Frederick Street and Queen's Park West (commonly referred to as "the Drag").

Roads closed to vehicular traffic

- 4. A driver of a motor vehicle shall not proceed, from 9.00 a.m. to 12.00 noon on—
  - (a) Frederick Street, between Queen's Park West and Keate Street;
  - (b) Queen's Park West, between Queen's Park East and Chancery Lane;
  - (c) Queen's Park East, between Jerningham Avenue and Queen's Park West;
  - (d) Charlotte Street, between Queen's Park West and Gordon Street;
  - (e) Keate Street, between Charlotte Street and Abercromby Street; and
  - (f) Pembroke Street, between Gordon Street and Keate Street.

Vehicular traffic diverted

- 5. A driver of a motor vehicle shall, from 9.00 a.m. to 12.00 noon, proceed—
  - (a) south on Queen's Park East, then turn east onto Jerningham Avenue;
  - (b) west on Jerningham Avenue, between Belmont Circular Road and Norfolk Street, then turn north or south onto Norfolk Street;
  - (c) south on Archer Street, then turn east onto Jerningham Avenue;
  - (d) north on Charlotte Street, then turn west onto Gordon Street; and
  - (e) north on Henry Street, then turn east onto New Street or west onto Gordon Street.

One-way traffic 6. A driver of a motor vehicle shall proceed along Jerningham Avenue, between Queen's Park East and Norfolk Street, in an easterly direction only, from from 8.00 a.m. to 12.00 noon.

7. During the observance of the two minutes of silence from 11.00 a.m. Two minutes to 11.02 a.m., police officers on duty shall bring to a standstill all vehicular traffic within the area bounded on the north by Queen's Park West, on the south by Gordon Street, on the east partly by Queen's Park East and partly by Charlotte Street and on the west by Chancery Lane.

8. Without prejudice to any liability incurred by the commission of a Removal and traffic violation, a motor vehicle found parked in contravention of this impounding of vehicles Order may be removed, impounded and dealt with in accordance with unlawfully parked sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
