REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing her from acting in any manner prejudicial to public safety and, that it is necessary to provide for her preventive detention, make an order that she be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to OLIVE GREEN-JACK of Saganga Trace, Morne Coco Road, Diego Martin, that it is necessary to provide for her preventive detention with a view to preventing her from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said OLIVE GREEN-JACK of Saganga Trace, Morne Coco Road, Diego Martin, shall be detained, and do hereby

authorise the Women's Prison Golden Grove, located at Golden Grove Road, Arouca or such other place as I may from time to time direct, as the place where the said OLIVE GREEN-JACK of Saganga Trace, Morne Coco Road, Diego Martin, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, OLIVE GREEN-JACK has made and published public posts and/or comments on social media addressed to the Venezuelan Government in an attempt to influence public opinion in a manner likely to be prejudicial to public safety. These public posts and comments invite violence on the Prime Minister, the Government of Trinidad and Tobago and members of the public by Venezuela and/or external persons. These activities reveal an imminent threat to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent her from acting in a manner prejudicial to public safety.
