THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KEVIN ANDREW MILLS of No. 4506 Winston Mulligan Drive, Phase 4, La Horquette, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me do hereby order that the said KEVIN ANDREW MILLS of No. 4506 Winston Mulligan Drive, Phase 4, La Horquette, shall be

detained, and do hereby authorise the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said KEVIN ANDREW MILLS shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, KEVIN ANDREW MILLS, a Customs Clerk Grade 2, has been identified as a pivotal suspect used to facilitate brazen and well-orchestrated attacks on innocent members of the public and law enforcement. Intelligence reveals that he is a member of the La Retreat Gang, an Organised Crime Group (OCG), which has been responsible for numerous violent offences, including homicides and serious woundings. Intelligence and crime analysis suggest that the detainee and members of the La Retreat Gang intend to carry out future brazen shootings and homicides, contrary to public safety. The said OCG has access to high-powered firearms and there is the further threat of imminent attacks and reprisals.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2025, is necessary to prevent him from acting in a manner prejudicial to public safety.
