ORDER

MADE BY THE MINISTER UNDER SECTION 8 OF THE VALUE ADDED TAX
ACT AND SUBJECT TO NEGATIVE RESOLUTION OF PARLIAMENT

THE VALUE ADDED TAX (AMENDMENT TO SCHEDULE 2)
(NO. 3) ORDER, 2025

1. This Order may be cited as the Value Added Tax (Amendment to Citation
Schedule 2) (No. 3) Order, 2025.

2. This Order comes into effect on 1st January, 2026.

Commencement

3. Schedule 2 of the Value Added Tax Act is amended—

Schedule 2
amended

- (a) in item 8(2)(a), by deleting the words “new electric motor vehicle,” and substituting the words “new electric motor vehicle with a C.I.F. value not exceeding four hundred thousand dollars and”;
- (b) in item 8(2)(b), by deleting the words “used electric motor vehicle,” and substituting the words “used electric motor vehicle with a C.I.F. value not exceeding four hundred thousand dollars and”;
- (c) in items 43(2)(b) and 43(4)(b), by deleting the words “three years” in both places where they occur and substituting in each place the words “eight years”; and
- (d) by inserting after item 52, the following item:

“53. The following items contained in the First
Schedule to the Customs Act and to be used in the
agricultural sector: Chap. 78:01”
