ORDER

MADE BY THE MINISTER UNDER SECTION 88D OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT AND SUBJECT TO NEGATIVE RESOLUTION OF PARLIAMENT

THE MOTOR VEHICLES AND ROAD TRAFFIC (AMENDMENT TO THE NINTH SCHEDULE) (NO. 4) ORDER, 2025

1. This Order may be cited as the Motor Vehicles and Road Traffic Citation (Amendment to the Ninth Schedule) (No. 4) Order, 2025.
2. This Order comes into effect on the 31st day of December, 2025. Commencement
3. Clause 3 of the Motor Vehicles and Road Traffic (Amendment to the Ninth Schedule) (No. 3) Order, 2025 is amended—  
L.N. No. 471 of 2025 amended
  - (a) by deleting paragraph (a) and substituting the following paragraph:  
“(a) in items 1, 5, 14, 19, 20, 38, 39, 44, 45, 46, 47, 50, 51, 52, 53, 54, 55, 56, 60, 64, 66, 67, 69, 75, 77, 78 and 93, by deleting the word “1,000.00” and substituting the word “2,000.00”;
  - (b) in paragraph (b), by deleting the word “32.”;
  - (c) by inserting after paragraph (b), the following paragraph:  
“(ba) in items 7, 8, 9, 10, 11, 17 and 91, by deleting the word “1,000.00” and substituting the word “1,500.00”;
  - (d) by deleting paragraph (c) and substituting the following paragraph:  
“(c) in item 12, by deleting the word “2,000.00” and substituting the word “3,750.00”;
  - (e) in paragraph (d), by deleting the word “6,000.00” and substituting the word “4,500.00”;
  - (f) by inserting after paragraph (e), the following paragraph:  
“(ea) in item 32, by deleting the word “750.00” and substituting the word “1,125.00”;

- (g) in paragraph (i), by deleting the word “and” in the last place where it occurs; and
- (h) by inserting after paragraph (i), the following paragraphs:

  - “(ib) in item 89, by deleting the word “2,000.00” and substituting the word “2,250.00”; and”.
