NOTICE OF A SPECIAL GENERAL MEETING

TO: ALL MEMBERS OF THE LAW ASSOCIATION OF TRINIDAD AND TOBAGO

The Council of the Law Association of Trinidad and Tobago hereby calls a **SPECIAL GENERAL MEETING (SGM)** of the Law Association of Trinidad and Tobago pursuant to Section 22, First Schedule of the Legal Profession Act Chap 90:03, which will be convened in a hybrid format on **Friday, 23rd January 2026 at 2:00 pm** at the Law Association of Trinidad and Tobago. The objective of the meeting is to consider the following resolution:

DRAFT RESOLUTION NO. 1

WHEREAS:

1. Under section 15(1A)(d) of the Legal Profession Act (LPA) Chap 90:03, nationals of Trinidad and Tobago may qualify to practice law locally upon successful completion of the Legal Practice Course (LPC) from an institution validated by the Law Society of England and Wales, payment of prescribed fees, and completion of the statutory attachment period.

AND WHEREAS:

2. The Solicitors Regulation Authority (SRA), the regulatory body for solicitors in England and Wales, has announced its intention to phase out the LPC as a route for qualification to the Roll of Solicitors in England and Wales with the full discontinuation of the LPC route by 31st December 2032 and institutions offering LPC programs will no longer receive validation from the SRA to do so from 2026.
3. The Council of the Law Association of Trinidad and Tobago generated a report dated 26 January 2017 entitled "The Proposed Amendments to the Legal Profession Act Chapter 90:03, Report of the Legal Profession Act Sub-Committee" and shared with the membership via email on 7 February 2017. The final report dated 8 March 2017 included a proposal to phase out the admission of LPC graduates over two years and comply with Treaty obligations under the Agreement defined in s. 2(1) of the Legal Profession Act and set out in the Schedule to the Council of Legal Education Act Ch. 39:50.

BE IT RESOLVED:

- (a) That the Law Association of Trinidad and Tobago recommends that the LPA be amended to discontinue qualification routes for the admission to practice law in Trinidad and Tobago which do not comply with obligations under the Treaty of Chaguaramas.

In the event that Resolution No.1 is not adopted, to consider the following resolution:

DRAFT RESOLUTION NO. 2

WHEREAS:

1. Under section 15(1A)(d) of the Legal Profession Act (LPA) Chap 90:03, nationals of Trinidad and Tobago may qualify to practice law locally upon successful completion of the Legal Practice Course (LPC) from an institution validated by the Law Society of England and Wales, payment of prescribed fees, and completion of the statutory attachment period.
2. The Solicitors Regulation Authority (SRA), the regulatory body for solicitors in England and Wales, has announced its intention to phase out the LPC as a route for qualification to the Roll of Solicitors in England and Wales with the full discontinuation of the LPC route by 31st December 2032 and institutions offering LPC programs will no longer receive validation from the SRA to do so from 2026.
3. The SRA has introduced a new route for qualification to the Roll of Solicitors in England and Wales, that being the Solicitors Qualifying Examinations (SQE).
4. Under the SQE regime, a person with an undergraduate degree is required to successfully complete two assessments (SQE1 and SQE2), undertake 2 years' qualifying work experience (QWE) in a legal environment and meet the SRA's character and suitability requirements to secure admission to the Roll of Solicitors in England and Wales.
5. Members of the Law Association of Trinidad and Tobago wish to retain admission routes to practise law in Trinidad and Tobago, which are alternative routes with obligations under the Treaty of Chaguaramas.

AND WHEREAS:

BE IT RESOLVED:

- (a) That the Law Association of Trinidad and Tobago recommend that Sections 15(1A)(c) and 15(1A)(d) of the LPA be retained.
- (b) That a recommendation be made for the LPA to be amended to accept the SQE as a valid educational component or requirement for nationals seeking admission to practice law in Trinidad and Tobago.
- (c) That a Bachelor of Laws Degree (LLB) shall be required as opposed to any other first degree (as obtains in the United Kingdom) in conjunction with the SQE for admission to practise law in Trinidad and Tobago.
- (d) That an aspirant attorney-at-law who has undergone the SQE assessment components (SQE1 and SQE2) and has not completed the two-year QWE component outside of Trinidad and Tobago shall

undertake a two-year period of training in Trinidad and Tobago, which shall be supervised by an attorney-at-law who has been admitted to practise for not less than ten years.

- (e) Where an aspirant attorney-at-law has completed the QWE component of the SQE route to qualification outside of Trinidad and Tobago, that person will only be required to undertake a six-month training period supervised by an attorney-at-law who has been admitted to practise for not less than ten years.
- (f) The question of whether an aspirant attorney-at-law shall receive remuneration during the training period shall be one for negotiations between the supervising attorney and their trainee.

NOTE:

1. Only financial practitioner members who hold a valid Practising Certificate for the law term 2025-2026 or who produce a receipt for Annual Subscription Fees and Contribution to the Compensation Fund for the 2025-2026 Law Term with a 2024-2025 Practising Certificate will be permitted to attend the SGM and will be permitted to cast their vote.
2. Financial practitioner members may attend the meeting in person or online. All voting will be conducted electronically regardless of mode of attendance.
