HEALTH SECTOR REFORM PROGRAMME CONSULTING SERVICES—NATIONAL COMMUNITY CARE PROGRAMME

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO is currently engaged in a Health Sector Reform Programme (HSRP) implemented by the Ministry of Health (MOH) and four Regional Health Authorities (RHAs). HSRP is being jointly financed by the Government and a loan from the Inter-American Development Bank (IDB). The MOH has undertaken the task of developing the standards and policies for the Community Care Programmes for the elderly and pediatric population. The programme will be designed to transfer the elderly and children who were inappropriately placed in institutions, into smaller community-based facilities. This would allow these populations to receive more appropriate care.

Interested candidates are invited to present their proposals, along with *curriculum vitae*, proof of experience and professional references for the consultancy listed below.

PROJECT CO-ORDINATORS: NATIONAL COMMUNITY CARE PROGRAMME—ELDERLY/CHILDREN

Job Summary

The objective of the Community Care Programme Co-ordinator (Elderly/Children) is to develop and implement plans to contract Non-Governmental Organizations (NGOs) and Community Based Organizations (CBOs) for provision of appropriate care to the elderly/child population who are currently inappropriately placed in hospitals. The position will be of interest to individuals with the relevant knowledge, skills and experience with NGOs/CBOs and the geriatric/pediatric population.

Activities

The activities required for this position will include—

- Preparation and implementation of a detailed work plan for the project.
- Conducting needs assessment of clients.
- Development of a detailed client classification system for the elderly and children.
- Familiarization with listings of NGOs and CBOs.
- Reviewing the delivery and quality of health care in NGOs and CBOs in order to make recommendations for improvement of service delivery.
- Assisting in the formulation of standards, protocol and models of care for the implementation of the project.
- Ensuring NGOs and CBOs compliance with policy and procedures set by MOH. Familiarization with the application process of the Community Development Fund (CDF).
- Development of training modules for NGOs and CBOs in the areas of protocol and procedure compliance in accordance with the MOH.
- Preparation of weekly/monthly reports in a clear and concise manner.

Qualification and Experience

The consultancies will be of interest to—

- (a) An individual with a baccalaureate degree in Community Health or Social Science and a minimum of five (5) years relevant experience with an excellent track record of achievement in the health field.
- (b) As an alternative, an individual with an associate degree in Community Health or Social Science and a minimum of eight (8) years relevant experience with an excellent track record of achievement in the health field.

The consultant must also have—

- (a) Excellent interpersonal and communications skills;
- (b) Knowledge of health care delivery;
- (c) The ability to prepare policies and procedures,
- (d) Ability to work with multi-disciplinary staff and to co-ordinate other professionals or working groups.
