TRINIDAD AND TOBAGO RACING AUTHORITY
AMENDMENTS TO RULES OF RACING

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules of Racing, 1991:

Rule 12—Appointment of Handicappers (delete reference to "and Classifiers")

- (a) The Promoter shall appoint a panel of not less than two handicappers whose duty shall include the assigning of the weights for handicaps and all other races on a race day, in conformity with these Rules.
- (b) All appointments of Handicappers shall be approved by the Authority prior to their commence of duty.

Rule 13—Restrictions Applying to Officials

In the first line delete "or classifier".

THE HANDICAPPER

Rule 19

In the first line of subsection (3) delete reference to "and classification".

Delete subsections 5, 6, 7 and 8 of this Rule as there will no longer be any provision for appeals.

ENTRIES, SUBSCRIPTIONS, DECLARATIONS TO RUN AND ACCEPTANCE FOR RACES: GENERAL

Rule 34(2)—is rescinded and revised to read—

Every entry, subscription or declaration to run shall be lodged at such a place not later than the prescribed hour on the day fixed for the closing of the same in the conditions of the race, and in such manner as the Stewards of the meeting shall direct. Any such entry, subscription or declaration is subject to alteration or withdrawal up to, but not after the time fixed for closing, except as provided in these Rules.

FORM OF ENTRY OR NOMINATION

Rule 36(6)—In line one, delete the words "or violation of rules", and replace with "affecting subsections (1) to (4) of this rule".

Rule 65—Appeals

Delete subsections (6) and (7), as there will no longer be any provisions for appeals against handicaps.

Rule 66—Error in the Entry

In the second line delete the words "or violation of a rule".

The above Amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 8th June, 2000.

CORRECTIONS TO AMENDMENTS OF THE TRINIDAD AND TOBAGO RACING AUTHORITY RULES OF RACING, 1991

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following corrections to the Schedule of Amendments to the Rules of Racing 1991, as approved at a meeting of the Authority held on Thursday 11th May, 2000.

Rule 2—Interpretation

"Promoter"—in the second line after the words "racecourse and", include "/or".

Rule 4—Appointment of Stewards

New subsection (5) to be renumbered (6).

Rule 6—Powers of the Stewards of Meeting

New subsection (1)(b)—in the fifth line include the word "such", before the word "action".

Present Rule 6A—The Stewards Secretary, to become subsection (6) and not (7) of Rule 6.

Rule 33—Disqualification of Horses

Reference to subsection (1)(b) which has been rescinded and replaced, should read subsection (2)(b).

Present subsections (1)–(6) to be renumbered subsections (2)–(6), as subsection (5) has been deleted.

CORRECTIONS/OMISSIONS TO AMENDMENTS OF THE TRINIDAD AND TOBAGO RACING AUTHORITY
RULES OF RACING 1991

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following corrections/omissions to the Schedule of Amendments to the Rules of Racing 1991, as approved by the Authority at a meeting held on Thursday 8th June, 2000.

Rule 6—Powers of the Stewards at Meetings

Subsection (1)(b) In the fifth line include the word "such" before the word "action".

(e) In the third line after the word "grooms" include "persons frequenting the stands or other places used".

Rule 6A—The Promoter

Subsection (2)(vi) In the first line replace the word "Starters" with the word "horses".

(vii) In the first line replace the words "Nom-de-plume" with "Assumed Name".

Rule 7—Powers of the Trinidad and Tobago Racing Authority

Delete present subsection (m) and replace same as subsection (n), with the following:

(n) Grant or refuse to grant and to renew or refuse to renew licences to persons requiring a licence under these Rules or the grant thereof, and to attach such conditions as it may deem expedient in the circumstances.

Reference to present subsections (g) to (r) to be renumbered (h) to (s), should read (i) to (t).

Rule 10—Appointment of Officials

Subsection (1)—In the first line include the word "Handicappers" before the word "Judge".

Rule 33—Registration of Foreign Horses

Subsection (1)—In the fourth line delete the words "and classification".
