JOINT JAPAN/WORLD BANK GRADUATE SCHOLARSHIP PROGRAMME—YEAR 2001 AWARDS

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO invites applications from nationals of Trinidad and Tobago for scholarships available under the Joint Japan/World Bank Graduate Scholarship Programme for studies commencing September, 2001.

2. This programme which has been established by the World Bank with funding from the Government of Japan is designed to allow individuals of World Bank member countries to pursue graduate studies in development related fields. The long term objective of the programme is to develop an international cadre of highly skilled professionals capable of advancing economic and social development in their individual countries.

Eligibility

3. In order to qualify for selection the applicant must—

- (a) be a citizen of the Republic of Trinidad and Tobago;
- (b) be under forty-five (45) years of age and normally under age thirty-five (35);
- (c) hold at least a Bachelor's Degree or its equivalent in a development related field, and have attained the degree with superior grades (at least upper second class honours);
- (d) have at least two (preferably four to five) years of recent professional experience in a field related to economic development preferably in the candidate's home country and in public service;
- (e) provide documentation to show he/she has applied to a graduate programme at two universities in any World Bank member country; and
- (f) propose a programme of study related to development which will usually be in a field such as Economics, Business, Planning or a related field.

Preparation and Submission of Applications

4. Interested persons are advised that application forms and detailed information concerning the terms of the award and the prescribed conditions for the submission of applications should be obtained from the following offices:

- (a) Scholarships and Advanced Training Division, Ministry of Finance, Planning and Development, ABMA Building, 55–57, St. Vincent Street, Port-of-Spain, (8.00 a.m. to 4.00 p.m. Monday to Friday);
- (b) Administration Building, Jerningham Street, Scarborough, Tobago; and
- (c) Offices of the Republic of Trinidad and Tobago Government Diplomat Missions.

5. Completed applications must reach the Scholarships and Advanced Training Division, Ministry of Finance, Planning and Development, preferably brought in by the applicants themselves at the above address, no later than November 16, 2000.

6. Applicants who are Public Officers must submit their application through their Permanent Secretaries/Heads of Department/Heads of Statutory Authorities, as appropriate.

7. Applications not submitted by the closing date or in accordance with the prescribed conditions will not be considered.
