PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE ASHTANG YOGA ASSOCIATION OF TRINIDAD AND TOBAGO AND FOR MATTERS INCIDENTAL THERETO

NOTICE is hereby given under the provisions of Standing Order 83(3)(b)(i) of the House of Representatives of a Bill entitled "An Act for the incorporation of the Ashtang Yoga Association of Trinidad and Tobago and for matters incidental thereto", which it is proposed to introduce in the House of Representatives.
