THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through the Ministry of Education (MOE) has accessed loan funding from the Inter-American Development Bank (IDB) for a Secondary Education Modernization Programme (SEMP) IDB Loan 1180/OC-TT, the goal of which is to modernize the secondary education sector in Trinidad and Tobago.

One component of the SEMP operation is the technical upgrade of the existing one hundred (100) secondary schools in Trinidad and Tobago. This technical upgrade consists of improvement works to the science laboratories, computer laboratories and libraries. This work is expected to be conducted in five (5) phases for the twenty (20) secondary schools. To fulfil its responsibility under this loan, the GORTT is inviting expression of interest from contractors.

Interested firms whether acting singly or in joint venture, are required to submit documentation and a completed questionnaire, which can be obtained from the Programme Co-ordinator at the address (1) below. All prequalification information should be submitted in the English language. After evaluation of the information submitted a shortlist of Contractors and/or joint ventures of Contractors will be selected and requested to submit proposals for the provision of the services.
