TRINIDAD AND TOBAGO RACING AUTHORITY

AMENDMENTS TO THE RULES OF RACING, 2000

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following amendments to the Rules of Racing, 2000.

PRIZES

Rule 56(6) is rescinded and replaced with the following.

56(6) Prize Money provided by the Conditions of races shall be paid to the owners of horses pursuant to these Rules, as follows:

- (1) In Graded/Subscription races—
 - (a) 60 per cent to the owner of the winner;
 - (b) 20 per cent to the owner of the second;
 - (c) 10 per cent to the owner of the third;
 - (d) 5 per cent to the owner of the fourth;
 - (e) 3 per cent to the owner of the fifth;
 - (f) 2 per cent to the owner of the sixth.

- (2) Other races of value \$25,000.00 and over—
 - (a) 50 per cent to the owner of the winner;
 - (b) 24 per cent to the owner of the second;
 - (c) 14 per cent to the owner of the third;
 - (d) 7 per cent to the owner of the fourth;
 - (e) 3 per cent to the owner of the fifth;
 - (f) 2 per cent to the owner of the sixth.

- (3) Races of value less than \$25,000.00—
 - (a) 50 per cent to the owner of the winner;
 - (b) 26.5 per cent to the owner of the second;
 - (c) 16 per cent to the owner of the third;
 - (d) 7.5 per cent to the owner of the fourth.

The above Amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 11th January, 2001.
