AMENDMENTS TO THE RULES OF RACING 2000

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise, of the following amendments to the Rules of Racing 2000:

2. Interpretation

In these Rules:

Include (new) before: "Added Money".

"Accredited Steward" shall mean a person who in the opinion of the Authority has successfully completed an approved Steward Accreditation program recognised by the said Authority and other Turf Authorities.

4. Appointment of Stewards

Include new subsection (2) to read:

"The Chairman of the Stewards for each raceday shall always be an Accredited Steward; unless otherwise authorised by the Authority".

Present subsections (2–6) to be renumbered (3–7)

Claiming

98 (i) In the first line after the words "without the permission" include "of the Stewards and/or", etc.

The above amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 15th February, 2001.
