PROPOSAL FOR TECHNICAL ASSISTANCE FOR CONSULTANCY SERVICES—TECHNO-ECONOMIC FEASIBILITY STUDY—NATIONAL ONCOLOGY CENTRE—HEALTH SECTOR REFORM PROGRAMME, MINISTRY OF HEALTH—IDB LOAN NO. 937/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through the Ministry of Health has initiated a comprehensive Health Sector Reform Programme (HSRP) aimed at improving the quality of health care by changing organizational structure(s) and behaviour(s). The costs of the HSRP are in part financed by a loan from the Inter-American Development Bank (IDB).

2. Technical assistance is being provided to the Ministry of Health in the planning, development and implementation of a number of strategies and systems including organizational, management and funding arrangements, primary health care and clinical information systems. Policy directions emphasize a shift in resources to primary care, a restructuring of secondary care and a resource allocation based on health need. Service devolution to Regional Health Authorities and the upgrading of physical infrastructure in both the primary care and hospital sectors form integral components of the overall reform initiative.

3. The National Health Services Plan (NHSP) has been developed to guide the infrastructure and human resource development required to achieve the shift in resources to primary and preventive care. The NHSP recognizes the importance of cancer treatment and recommends improvements in inpatient facilities consistent with rationalization of tertiary care services. The NHSP calls for the establishment of a National Oncology Centre at the Eric Williams Medical Sciences (EWMSC) aimed at earlier diagnosis, effective treatment and care, and a reduction in cancer mortality and morbidity.

4. The objective of this consultancy is to undertake a National Oncology Centre economic feasibility study to provide the functional link between national oncology programme planning and facility planning.
