TENDERS are invited for the provision of Consultancy Services which includes Architectural, Project Management, Civil and Structural, Mechanical/Electrical Engineering and Quantity Surveying Services, for Restoration Works to President's House and Queen's Royal College for the Ministry of Infrastructure Development and Local Government.
