### COMMENCEMENT OF ELECTORAL REGISTRATION

MEMBERS OF THE PUBLIC in general and political parties and registered electors in particular, are hereby notified that under section 30 of the Representation of the People Act, Chap. 2:01, His Excellency the President, has issued a Proclamation fixing Monday 5th November, 2001 as the date for the commencement of an Electoral Registration in the thirty-six (36) Parliamentary Electoral Districts in Trinidad and Tobago.

In accordance with the said section 30 and Registration Rules 52 and 53, the Electoral Registration will be conducted in the various Registration Area Offices and the Temporary Registration Area Offices established for the purpose, during the period Monday 5th November, 2001 to Tuesday 13th November, 2001.

The exercise is intended to facilitate those persons who—

- (1) have attained the age of 18 years and over, but who have not been registered as electors;
- (2) have been registered as electors but have changed their addresses and have not yet notified the Registration Officer of such change of address;
- (3) have been registered as electors and have changed their names because of marriage or otherwise, but their previous names appear on the Preliminary List of Electors;
- (4) have been registered as electors but their names do not appear on the Preliminary List of Electors.

During the period of the Electoral Registration, business will be conducted at the Registration Area Offices and at the Temporary Registration Area Offices

Monday to Friday—8.00 a.m. to 6.00 p.m.

Saturday and Sunday—9.00 a.m. to 6.00 p.m.

It is important to note that at the close of business on TUESDAY 13TH NOVEMBER, 2001 no further registration or registration related matters will be effected.
