REVOCATION OF APPOINTMENT OF A PRIVATE WAREHOUSE/CUSTOMS AREA (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, do hereby revoke the appointment of the place described in the Schedule hereunder as a Private Warehouse, which said place was appointed a Private Warehouse by the Comptroller of Customs and Excise for the warehousing of certain goods by Messrs. Pharmaceutical Products (imported by—P.I. Caribbean Limited and Sterling Drugs International) of Lady Young Road, Morvant, under the provisions of section 263(2) of the Customs Act, Chap. 78:01 and which said appointment was published as Notice No. 1496 dated 28th May, 1996 in the *Trinidad and Tobago Gazette*.

SCHEDULE

TWO (2) ROOMS. (1) A room measuring 17.6 m on its Northern and Southern sides and 10.7 m on its Eastern and Western sides, comprising a total square area of 188.32 m² and constructed essentially of concrete blocks in a steel frame-work and covered by a roof of galvanized iron sheets. (2) A room adjacent to and situated north of the above-mentioned room measuring 11m x 15.95 m comprising an area of 175.45 m and also constructed essentially of concrete blocks in a steel frame-work and covered by a roof of galvanized iron sheets. The rooms are housed in a building formerly used by Neal and Massy Limited as a Customs Private Warehouse, located at the eastern end of Neal and Massy compound, situate at Lady Young Road, Morvant, and bounded on the north partly by lands owned by Mary M. West and partly by lands formerly owned by R. Mulhemann now belonging to the State, on the south by a Road Reserve 15 feet wide, on the east by lands owned by C. L. Young and on the west by lands of the State.
