BILL

An Act to provide for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2024

Explanatory Note

(This note forms no part of the Bill but is intended only to indicate its general purport)

The Bill seeks to provide for the service of Trinidad and Tobago for the financial year ending September 30, 2024 by authorising the issue from the Consolidated Fund of the sum of Fifty Thousand, Seven Hundred and Forty-Five Million, Two Hundred and Fifteen Thousand, Nine Hundred and Ninety-One Dollars (\$50,745,215,991).

BILL

An Act to provide for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2024

[, 2023]

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:

1. This Act may be cited as the Appropriation short title (Financial Year 2024) Act, 2023.

Issue from the Consolidated Fund authorised

2. (1) The issue from the Consolidated Fund of the Fifty Thousand, Seven Hundred Forty-Five Million, Two Hundred and Fifteen Thousand, Nine Hundred and Ninety-One Dollars (\$50,745,215,991) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2024, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of Fifty Thousand, Seven Hundred and Forty-Five Million, Two Hundred and Fifteen Thousand, Nine Hundred and Ninety-One Dollars (\$50,745,215,991) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2024.

Commencement

3. This Act is deemed to have come into force on the 1st day of October, 2023.
