NOTICE is hereby given that Shell Trinidad and Tobago Limited and Shell Trinidad and Tobago Resources S.R.L. is desirous of drilling eight offshore wells and the establishment of a normally unattended installation platform within the Manatee Field Block 6D, and the establishment of a 105 km offshore/onshore 36-inch pipeline and associated upgrades to the Beachfield Gas Reception Facility, South-East Coast, Trinidad. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order thus requiring a Certificate of Environmental Clearance pursuant to **Section 35 of the Environmental Management Act, Chapter 35:05 ("the Act")**.
