UPON READING the Fixed Date Claim Form filed on the 13th day of April, 2023, the Certificate of Urgency filed on the 13th day of April 2023, the Notice of Application dated the 13th April 2023 and the affidavit of [REDACTED] sworn to and filed on the 13th day of April, 2023 together with the exhibits attached thereto;

AND UPON the matter being determined in Chambers without a hearing.

IT IS HEREBY DECLARED that Pursuant to Section 22B(3)(a) of the Anti-Terrorism Act, the Defendant, Date of Birth November 30, 2000; Citizen of the United States of America and Citizen of Descent of Trinidad and Tobago; Birth Certificate registration number 5479; Previous address #12 Rio Claro Mayaro Road, Rio; currently incarcerated by law enforcement authorities of the United States of America as inmate number 10414-509 last known to be detained at FCI Coleman Medium, 846 NE 54th Terrace Sumterville, Florida, 33521, is a listed entity for the purposes of the Anti-Terrorism Act, Chapter 12:07 ("the Act").

IT IS FURTHER ORDERED that:

1. Pursuant to section 22B(3)(b) of the Act that the property
 - (i) owned or controlled by the Defendant;
 - (ii) wholly or jointly owned or controlled, directly or indirectly, by the Defendant; and
 - (iii) derived or generated from funds or other assets owned or controlled directly or indirectly by the Defendant, be frozen;
2. Pursuant to section 22B(4D)(b) of the Act, the Registrar of the Supreme Court do serve an Office Copy of the Order on the Financial Intelligence Unit immediately in accordance with the Civil Proceedings Rules 1998 (as amended);
3. Pursuant to section 22B(5) of the Act, the Attorney General shall within seven (7) days after the date of this Order, cause a copy of the Order and a statement that the matter will be reviewed every six (6) months, to be published in the Trinidad and Tobago Gazette and in two (2) daily newspapers of general circulation in Trinidad and Tobago;
4. Liberty to apply; and
5. Costs to be costs in the cause.

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act (FOIA), Chapter 22:02 the **Eastern Regional Health Authority (ERHA)** is required by law to publish the following statement, which lists the documents and information generally available to the public.

The Freedom of Information Act gives members of the public:

1. A legal right for each person to access information held by the ERHA;
2. A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading;
3. A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA; and
4. A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Section 7 (1) (a) (i)

Function and Structure of the Eastern Regional Health Authority

The Eastern Regional Health Authority (ERHA) is a Statutory Body which was established on May 20, 1994 in accordance with the Regional Health Authorities Act No. 5 of 1994. It is governed by a Board of Directors.

ERHA is, geographically, the largest of the Regional Health Authorities in Trinidad and Tobago. It encompasses the St. Andrew, St. David, Nariva and Mayaro counties. The ERHA delivers health care services to an area extending from the northeastern most point of Matelot to the southeastern most tip of Guayaguayare and as far westward as the communities of Rio Claro, Brother's Road, Cumuto and Valencia.

The Authority delivers healthcare via the Sangre Grande Hospital, the Mayaro District Health Facility, fourteen (14) Health and Outreach Centres, Nariva Mayaro Satellite Dialysis Unit and the Sangre Grande Enhanced Health Centre. ERHA facilities also include a Head Office, County Health Administration Offices in Nariva/Mayaro and St. Andrew/St. David, a Learning Resource Centre, a Conference Centre and Disaster Preparedness Emergency Operations Centre and a Community Liaison Unit.

The services of the ERHA are specifically geared toward the 120,000 resident population of the Eastern Region. However, individuals from all over Trinidad and Tobago have access to our services, including visitors to our region.

The ERHA's mission is to develop resources and execute on plans which build an enabling environment for the delivery of a broad range of high quality people-centered health care services in support of the strategic goals of the Ministry of Health.

The vision states that the ERHA is a people-centered, caring, proactive institution which provides excellence in medical care and patient service, thereby promoting, protecting and improving the health status of the population of the eastern region of Trinidad and Tobago.

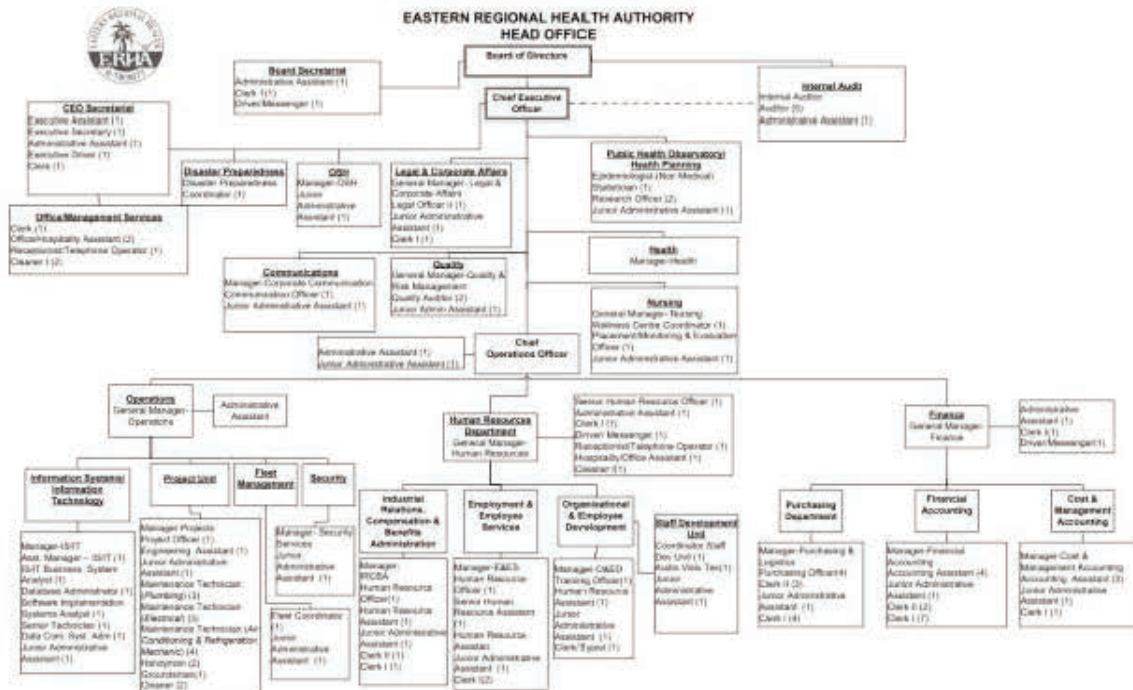

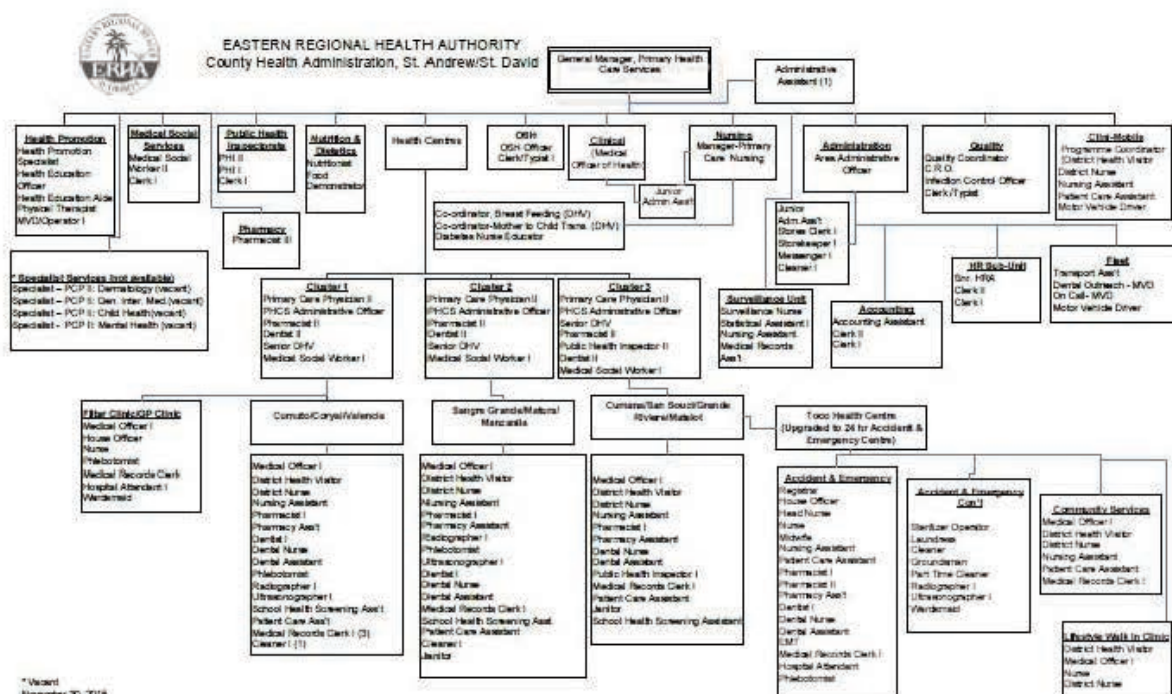

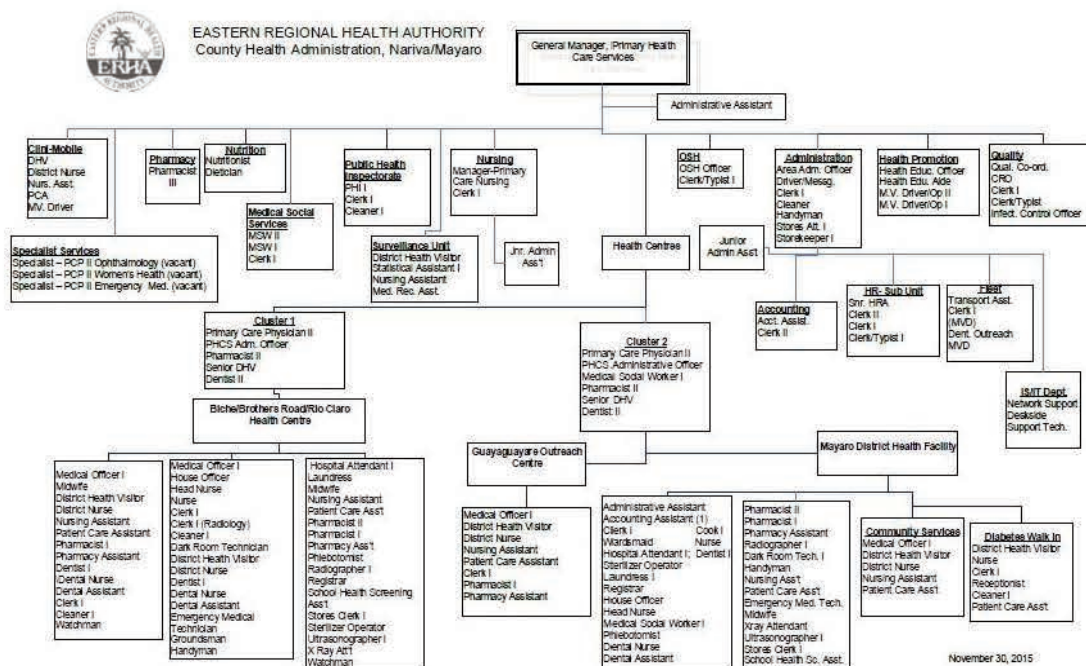

Organisational Structure – County Nariva/Mayaro

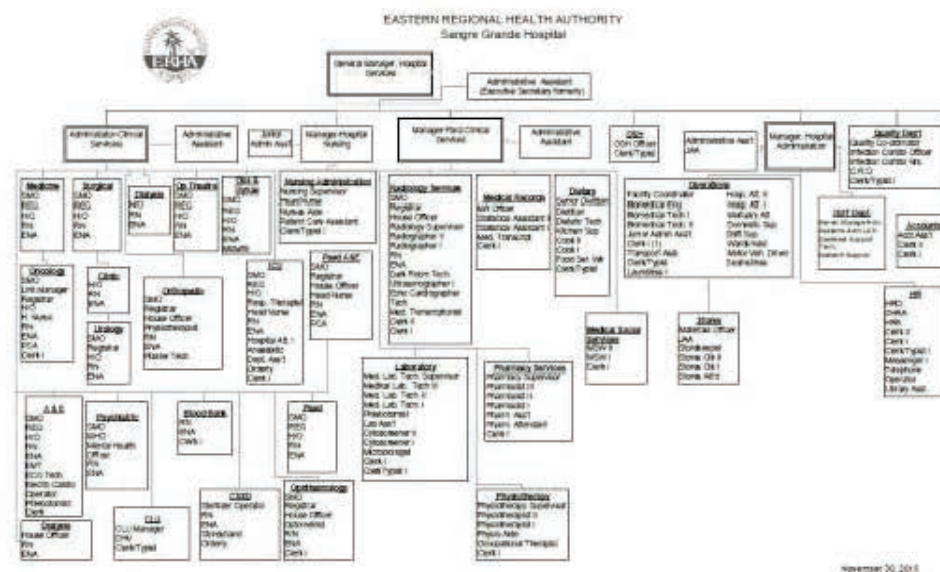


4. Sangre Grande Hospital

The Sangre Grande Hospital, located at Ojoe Road, Sangre Grande, is the only facility with in-patient services in the Eastern Regional Health Authority. The facility currently has 147 beds and provides secondary care for the Counties of St. Andrew/St. David and Nariva/Mayaro with an estimated population of 120,000 persons. Some of the services provided include Oncology, Accident and Emergency, Orthopaedics, Ophthalmology, Radiology, Blood Bank, a Poison Information Centre and Computed Tomography Suite.

Procedure to be followed when accessing a document from the Eastern Regional Health Authority

How to Request Information

General Procedure

In order to have the rights given to applicants by the FOIA (for example the right to challenge a decision if the request for information is refused), **the applicant must make their request in writing**. The *Request for Access to Official Documents* form is available for download on the ERHA's website under the Resources link or in the Reception Areas of our Head Office and our administrative offices (described above). The relevant information that **must be** provided to the ERHA includes:

- Name of Applicant (full name preferred);
- Contact information;
- Information requested and format to provide the information;
- Date of request;
- Signature of applicant;
- Applications should be addressed to the Designated Officer of the ERHA (**see Section 7 (1) (a) (vi)**).

Applicants should provide details that will allow for ready identification and location of the records that are being requested. If insufficient information is provided, clarification will be sought from the applicant. If the applicant is not sure how to prepare their request or what details to include, they should communicate with the Designated Officer. The applicant will be contacted **within thirty (30) days** of the receipt of the request by the ERHA (that is, the received stamp date) and the applicant will be notified by the Designated Officer that the request has been received and is being considered. After determining if the request can be made available to the applicant (approval), the applicant will be informed and given a time period in which the information will be disclosed. If it is determined that the request cannot be disclosed (refusal) then the applicant will be informed of the refusal and the rights of the applicant according to Section 38A and 39 of the FOIA.

Requests not handled under the FOIA

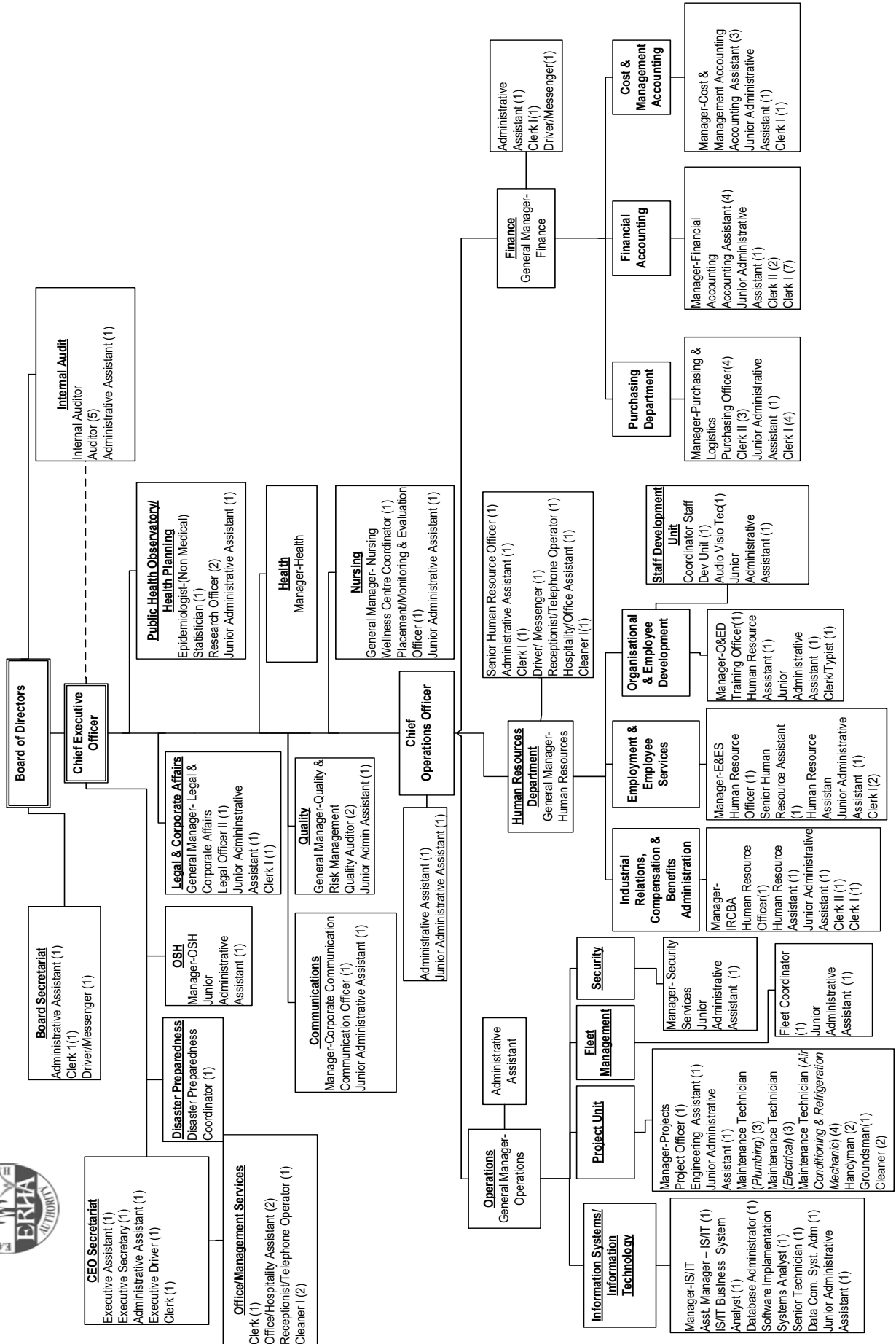

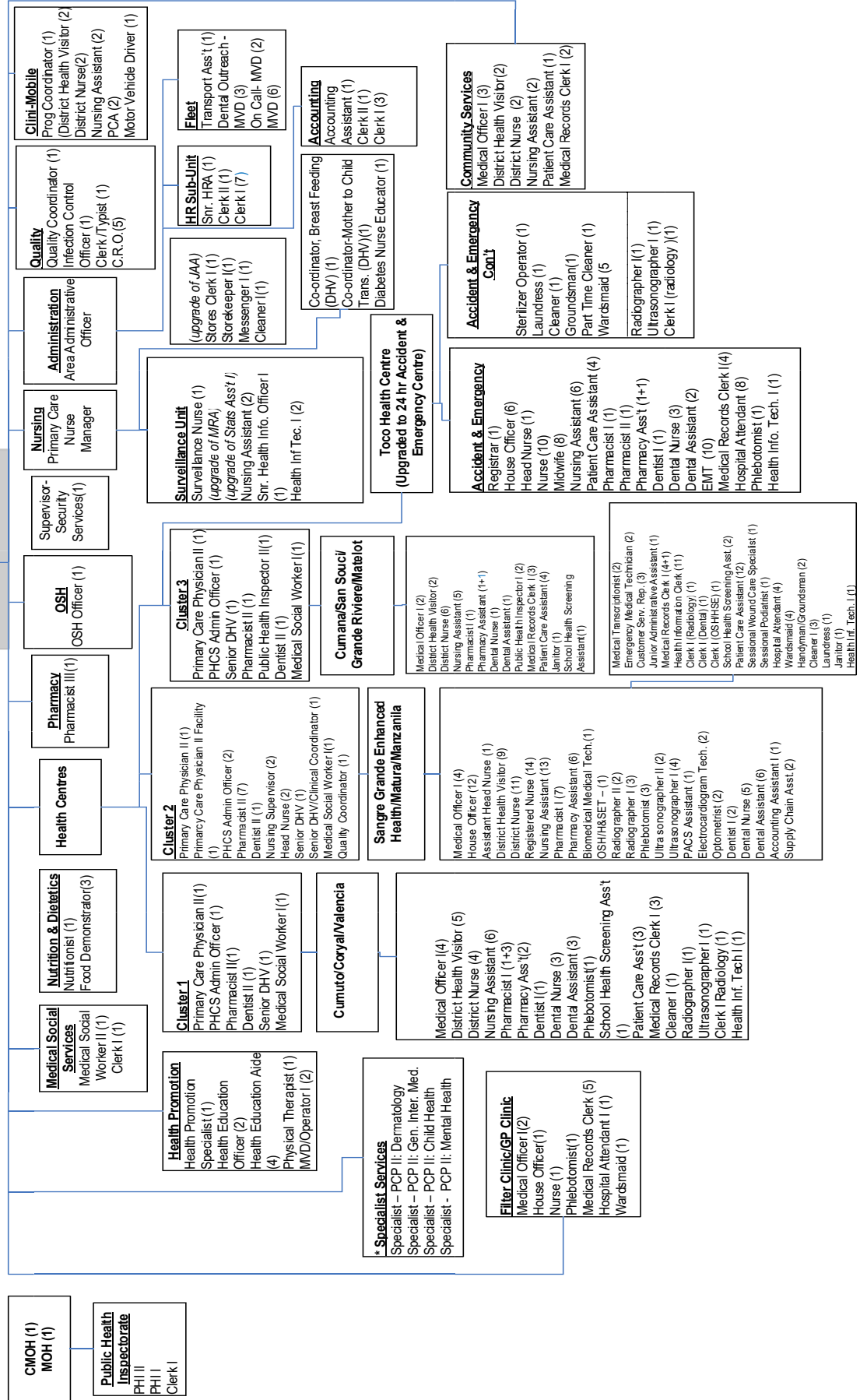

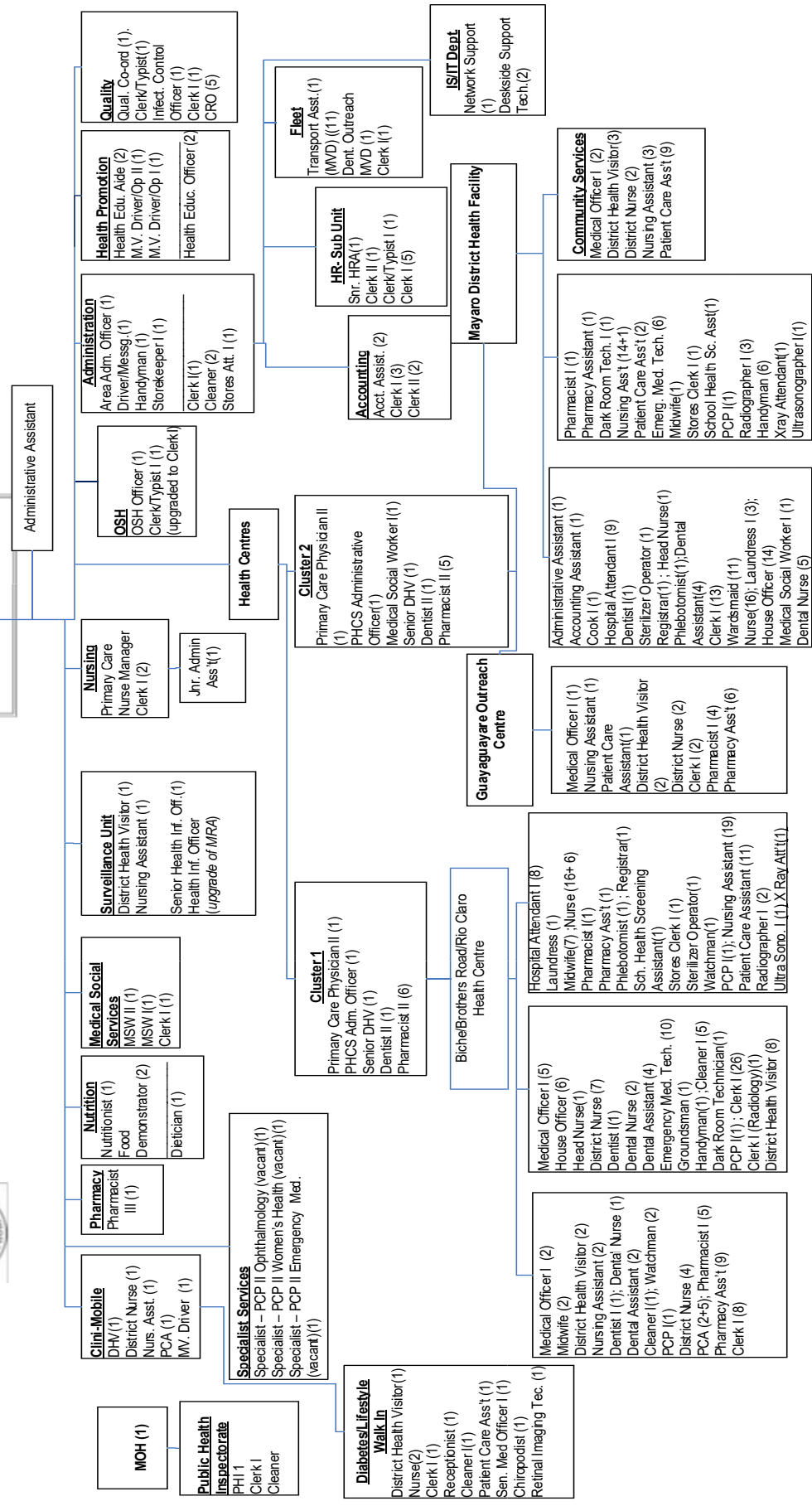

RESOLUTION 1:**RESOLUTION TO BE ADOPTED FOR TEMPORARY REGISTRATION: ONE-YEAR LIMITED**

CANDIDATES WHO ARE GRADUATES FROM A MEDICAL SCHOOL NOT LISTED IN THE WORLD HEALTH ORGANIZATION LIST OF MEDICAL SCHOOLS BUT WHOSE SCHOOL IS RECOGNISED BY THE ACCREDITATION COUNCIL OF TRINIDAD AND TOBAGO AND HAVE COMPLETED ALL PARTS OF THE UNITED STATES MEDICAL LICENSING EXAMINATION, MEDICAL COUNCIL OF CANADA QUALIFYING EXAMINATION, AUSTRALIAN MEDICAL COUNCIL OR CARIBBEAN ASSOCIATION OF MEDICAL COUNCIL EXAMINATIONS AND AN APPROVED INTERNSHIP PERIOD.

Whereas, candidates who graduated from medical schools which were not listed in the World Health Organization list of medical schools but whose school is recognized by the Accreditation Council of Trinidad and Tobago and completed all parts of the United States Medical Licensing Examination, Medical Council of Canada Qualifying Examination, Australian Medical Council or Caribbean Association of Medical Council examinations and are eligible for Full Registration, the Council recognized that there was a need to assess these candidates fitness to practice medicine in our local jurisdiction with respect to cultural differences and effective communication through a period of Temporary Registration for one year.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- Candidates who are graduates of a medical school not listed in the World Health Organization list of medical schools, but whose school is recognized by the Accreditation Council of Trinidad and Tobago and have completed all parts of the United States Medical Licensing Examination, Medical Council of Canada Qualifying Examination, Australian Medical Council or Caribbean Association of Medical Council examinations and an approved internship period, would be required to complete one year of Temporary Registration before applying for Full Registration with the Medical Board of Trinidad and Tobago.

RESOLUTION 2:**RESOLUTION TO BE ADOPTED FOR TEMPORARY REGISTRATION: THREE-MONTHS**

CANDIDATES WHO ARE CITIZENS OF TRINIDAD AND TOBAGO AND ARE GRADUATES FROM A MEDICAL INSTITUTION OTHER THAN THE UNIVERSITY OF THE WEST INDIES BUT WHOSE SCHOOL IS RECOGNISED BY THE ACCREDITATION COUNCIL OF TRINIDAD AND TOBAGO AND WHO HAVE COMPLETED ALL PARTS OF THE UNITED STATES MEDICAL LICENSING EXAMINATION, MEDICAL COUNCIL OF CANADA QUALIFYING EXAMINATION, AUSTRALIAN MEDICAL COUNCIL OR CARIBBEAN ASSOCIATION OF MEDICAL COUNCIL EXAMINATIONS AND AN APPROVED INTERNSHIP PERIOD.

Whereas citizens of Trinidad and Tobago who are graduates of a medical school other than the University of the West Indies, and whose school is recognized by the Accreditation Council of Trinidad and Tobago and have completed all parts of the United States Medical Licensing Examination, Medical Council of Canada Qualifying Examination, Australian Medical Council or Caribbean Association of Medical Council examinations and an approved period of internship,

are eligible for Full Registration, the Council recognized that these candidates are already familiar with the cultural differences and communication styles of our setting but would benefit from a period of supervised adjustment to the local health care system as part of the candidates assessment to practice medicine in our jurisdiction.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- Candidates who are citizens of Trinidad and Tobago, who are graduates of a medical school other than the University of the West Indies, and whose school is recognized by the Accreditation Council of Trinidad and Tobago and have completed all parts of the United States Medical Licensing Examination, Medical Council of Canada Qualifying Examination, Australian Medical Council or Caribbean Association of Medical Council examinations and an approved internship period, would be required to complete three months of Temporary Registration before applying for Full Registration with the Medical Board of Trinidad and Tobago.

RESOLUTION 3:

RESOLUTION TO BE ADOPTED FOR THE RECOGNITION OF THE M.B.B.S. DEGREE FROM THE UNIVERSITY OF THE WEST INDIES, ALL CAMPUSES INCLUDING BAHAMAS AS AN ACCEPTABLE DIPLOMA FOR TEMPORARY REGISTRATION.

Whereas from January 1st, 2004, graduates from the University of the West Indies were now required to complete all parts of the United Kingdom's General Medical Council's Professional and Linguistic Assessment Board Test for registration with the General Medical Council, meant that these graduates could no longer be registered with the Medical Board of Trinidad and Tobago under Section 12 of the Medical Board Act Chapter 29: 50, Act 35, 1960.

Section 13 of said Act provides for Full Registration after a period of Temporary Registration. Section 13 of the Act also provides for the Council to determine the acceptability of medical diplomas for the purpose of Temporary Registration. The Council seeks to recognize the M.B.,B.S. medical diploma issued by the University of the West Indies, all campuses including Bahamas, as an acceptable medical diploma for Temporary Registration.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- The M.B.,B.S. medical diploma issued by the University of the West Indies, all campuses including Bahamas, is an acceptable medical diploma for Temporary Registration.

RESOLUTION 4:

RESOLUTION TO BE ADOPTED FOR TEMPORARY REGISTRATION: ONE-MONTH.

GRADUATES OF THE UNIVERSITY OF THE WEST INDIES, ALL CAMPUSES INCLUDING BAHAMAS

Whereas from January 1st, 2004, graduates from the University of the West Indies were now required to complete all parts of the United Kingdom's General Medical Council's Professional and Linguistic Assessment Board Test for registration with the General Medical Council, meant

that these graduates could no longer be registered with the Medical Board of Trinidad and Tobago under Section 12 of the Medical Board Act Chapter 29: 50, Act 35, 1960. Section 13 of said Act provides for Full Registration after a period of Temporary Registration and gives the Council the authority to determine the time of Temporary Registration. The Council recognized that graduates of the University of the West-Indies, all campuses including the Bahamas, were traditionally granted Full Registration, and have sought to maintain this precedent while complying with the Medical Board Act under Section 13. In this respect, the Council seeks to grant Full Registration to all candidates of the University of the West-Indies, all campuses including the Bahamas, after a period of one-month Temporary Registration.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- Graduates of the University of the West Indies, medical faculty, all campuses including Bahamas, having completed an approved period of internship, would be granted one-month Temporary Registration before being approved for Full Registration.

RESOLUTION 5:

A RESOLUTION TO BE ADOPTED FOR THE RATIFICATION OF FULL REGISTRATION STATUS OF ALL UWI GRADUATES FROM ALL CAMPUSES INCLUDING BAHAMAS REGISTERED WITH THE MEDICAL BOARD OF TRINIDAD AND TOBAGO FROM JANUARY 1ST 2004 TO SEPTEMBER 14TH 2022.

Whereas from January 1st, 2004, graduates from the University of the West Indies were now required to complete all parts of the United Kingdom's General Medical Council's Professional and Linguistic Assessment Board Test for registration with the General Medical Council, meant that these graduates could no longer be registered with the Medical Board of Trinidad and Tobago under Section 12 of the Medical Board Act Chapter 29: 50, Act 35, 1960. Section 13 of said Act provides for Full Registration after a period of Temporary Registration. Section 13 of the Act also provides for the Council to determine the acceptability of medical diplomas for the purpose of Temporary Registration. The Council recognizes that M.B.,B.S. graduates from the University of the West Indies, continued to be granted Full Registration after a period of approved internship even after the amendment to GMC registration requirements of December 31st, 2003. The Council seeks to regularize the registration status of all University of the West Indies graduates who were inadvertently granted Full Registration after January 1st, 2004, under Section 12 of the Medical Board Act Chapter 29:50.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- All medical graduates of any campus of the University of the West-Indies including the Bahamas, who were granted Full Registration with the Medical Board of Trinidad and Tobago between the period January 1st 2004 and September 14th 2022, who would have had to satisfy the requirement of a period of Temporary Registration under Section 13 of the Medical Board Act of Trinidad and Tobago, would now have that requirement waived and have their Full Registration status recognized by the Medical Board of Trinidad and Tobago.

RESOLUTION 6:

A RESOLUTION TO BE ADOPTED FOR THE ADDITION OF A HEALTH SCREENING QUESTION TO THE FITNESS TO PRACTICE ASSESSMENT FOR NEW APPLICANTS.

Whereas Section 12 of the Medical Board Act Chapter 29:50 makes provision for Full Registration of a candidate who is registered with the GMC-UK or registrable with the GMC-UK. One of the criteria for registration with the GMC-UK is the completion of a Fitness to Practice questionnaire. The Fitness to Practice questionnaire has two areas which are enquired about, the first is the candidate's health condition, the second is their professional performance. The MBTT currently has five screening questions that ask about the candidate's fitness to practice on the application for Full Registration. The GMC-UK fitness to practice form varies in one category that is not addressed in the application form of the MBTT and this is with respect to the candidate's health and its impact on the candidate's fitness to practice. The Council seeks to add a health screening question to the MBTT's application form which would serve to align both the GMC-UK and MBTT fitness to practice screening tools.

BE IT RESOLVED that the following be adopted on 14th September 2022, as constituting the policy guidelines of the Medical Board of Trinidad and Tobago.

- All application forms for registration with the Medical Board of Trinidad and Tobago should now include the following question as a health screening tool:
 - a. Do you have a health condition that may impact on the safe performance of your duties as a medical doctor?
 - b. If your answer is yes or you are unsure, please provide a medical report from a specialist in the relevant field of medicine.
