PRIVATE BILL—AN ACT TO AMEND THE TRINIDAD AND TOBAGO NATIONAL COUNCIL ON ALCOHOLISM (INCORPORATION) ACT, NO. 36 OF 1977.

PUBLIC NOTICE is hereby given in accordance with House of Representatives Standing Order 75(3)(b) that the above-mentioned Bill will be introduced in the House of Representatives.

2. Notice of the intended introduction of the Bill is being given in the *Trinidad and Tobago Gazette* and copies of the Bill may be purchased from the Government Printer. The Bill is also available at www.ttparliament.org.

3. The object of the Bill, among other things, is to amend the Trinidad and Tobago National Council on Alcoholism (Incorporation) Act, 1977 and provide for change in name of the organisation to the Centre for Addiction Prevention and Healthy Living. The Bill will also amend the aims and objectives of the organisation to accurately reflect its expanded work in treating all types of addiction, and not just alcoholism.
