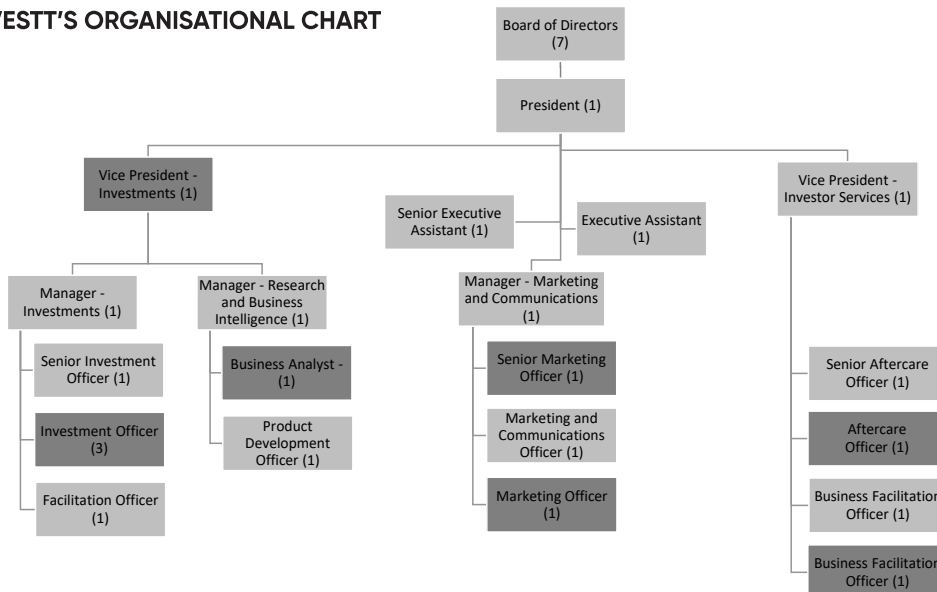
Investments
