ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER,
2023

1. This Order may be cited as the Traffic Restriction (Temporary Citation
Provisions) (Point Fortin Borough Day Celebrations) Order, 2023.

2. This Order shall have effect between the hours of 5.00 a.m. to Duration
2.00 p.m. on Friday 28th April, 2023 for the Military Parade, and
between the hours of 6.00 p.m. on Friday 5th May, 2023 to 4.00 a.m.
and 6.00 p.m. on Sunday 7th May, 2023.

3. A driver shall not park his motor vehicle on—

Parking
prohibited

- (a) Bryce Road;
- (b) Tanner Street;
- (c) Reid Road;
- (d) Atlantic Avenue;
- (e) Main Field Road;
- (f) Morris Road;
- (g) Church Road;
- (h) Montano Street;
- (i) Nurse Street;
- (j) Alleyne Street;
- (k) School Road;
- (l) Point Fortin Main Road, between Dunlop Roundabout and
Refinery Road;
- (m) Techier Main Road, between Handel Street and First
Street;
- (n) Second Street, between First Street and Eastern Avenue;
- (o) Eastern Avenue, between Second Street and Point Fortin
Main Road;

- (p) Warden Road, between Guapo-Cap-de-Ville Road and the Southern Main Road;
 - (q) Clifton Hill Road between Richardson Street, Volunteer Road and Guapo-Cap-de-Ville Road;
 - (r) Southern Main Road, between North Trace Junction and Food Crop Road No. 2;
 - (s) Sergeant Street;
 - (t) George Street;
 - (u) Canaan Road;
 - (v) Wickham Street;
 - (w) Guava Road;
 - (x) Agard Road; and
 - (y) the emergency route prescribed under clause 7.
- Vehicular traffic prohibited
4. A driver shall not drive his motor vehicle on—
- (a) Guapo-Cap-de-Ville Road, between Bryce Road and Richardson Street;
 - (b) Tanner Street, between Bryce Road and Point Fortin Main Road;
 - (c) Point Fortin Main Road, between Reid Road and Tanner Street;
 - (d) Techier Main Road, between Handel Street and Frisco Roundabout; and
 - (e) Bryce Road, between Wickham Street and Guapo-Cap-de-Ville Road.
- One-way traffic
5. A driver shall proceed along—
- (a) Reid Road, between Point Fortin Main Road and Montano Street, in a westerly direction only.
 - (b) Montano Street, between Bryce Road and Reid Road, in a southerly direction only;
 - (c) Bryce Road, between Montano Street and Point Fortin Main Road, in an easterly direction only; and
 - (d) Point Ligoure Road, between Point Fortin Main Road and Guapo-Cap-de-Ville Road, in a northerly direction only.
- Traffic route
6. (1) A driver entering Point Fortin from the Southern Main Road shall—
- (a) proceed in a westerly direction along the Point Fortin Main Road, then west along Reid Road; or
 - (b) turn right onto Techier Main Road, proceed north onto Canaan Road, onto Volunteer Road; or

- (c) turn right onto Techier Main Road, proceed north onto Canaan Road, west along Richardson Road and onto Guapo-Cap-de-Ville Road.

(2) A driver leaving Point Fortin from the Guapo-Cap-de-Ville Road shall turn right onto Reid Road and then turn right onto Point Fortin Main Road.

(3) A driver shall exit the following roads by proceeding as follows:

- (a) from Techier Main Road, continuing east onto Second Street, then south onto Eastern Avenue, then onto that part of the Point Fortin Main Road known as Egypt Main Road, and onto the Southern Main Road towards San Fernando;
- (b) from Guapo-Cap-de-Ville Road, turn left onto Reid Road, then onto that part of the Point Fortin Main Road known as Egypt Main Road, and south onto the Southern Main Road towards San Fernando; and
- (c) from Guapo-Cap-de-Ville Road, south onto Warden Road, then turn left onto Gerald Street, and onto the Southern Main Road towards San Fernando.

(4) A driver shall exit Atlantic Avenue by proceeding as follows:

- (a) south onto Reid Road, then north onto that part of the Point Fortin Main Road known as Egypt Main Road, and onto the Southern Main Road towards San Fernando; or
- (b) south onto Guapo-Cap-de-Ville Road, then west onto Warden Road, continuing onto Pilgrim Street, then turn left onto High Street and onto the Southern Main Road; or
- (c) further south from Cap-de-Ville Road, will proceed onto the San Fernando-Siparia-Erin Road.

7. A driver who has an emergency shall proceed in a northerly direction from Atlantic Avenue onto Point Ligoure Road, onto Refinery Road, north onto Guapo-Cap-de-Ville Road, east onto Clifton Hill Road, south onto Volunteer Road, onto Richardson Street, left onto Canaan Road, then in a southeasterly direction onto Techier Main Road, continuing southeasterly onto Second Street then in a southerly direction onto Eastern Avenue, and then in an easterly direction onto Point Fortin Main Road towards San Fernando.

8. The following taxi stands are relocated as follows:

- (a) the San Fernando taxi stand, to the lay-by on the eastern side of Point Fortin Main Road, approximately 500 metres north of Frisco Roundabout;

- (b) the Cedros and Erin taxi stands, to the car park of the Point Fortin Catholic Church on the eastern side of the Guapo-Cap-de-Ville Road in the vicinity of the Guapo-Cap-de-Ville Road and Reid Road intersection; and
- (c) the La Brea, Gonzales, Techier, Egypt and New Village stands, to the car park between Morelow Supermarket and Traffic Office located at Southern Main Road, Point Fortin approximately 600 metres north of Frisco Roundabout.

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the police and impounded at the Point Fortin Borough Yard located at the Guapo-Cap-de-Ville Main Road and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
