ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CEREMONIAL OPENING OF PARLIAMENT OF THE
REPUBLIC OF TRINIDAD AND TOBAGO) ORDER, 2023

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Ceremonial Opening of Parliament of the Republic of Trinidad and Tobago) Order, 2023.

2. This Order shall have effect from 6.00 a.m. to 5.00 p.m. on Duration Monday 11th September, 2023.

3. (1) The driver of a motor vehicle is prohibited from parking on the following roads: ^{Parking prohibited}

- (a) St. Vincent Street, between Duke Street and Independence Square North;
- (b) Sackville Street, between Richmond Street and St. Vincent Street;
- (c) Abercromby Street, between Independence Square North and Park Street;
- (d) Knox Street, between Abercromby Street and Frederick Street;
- (e) Edward Street, between Independence Square North and Park Street;
- (f) Hart Street;
- (g) Duke Street, between Frederick Street and Edward Street;
- (h) Pembroke Street, between Knox Street and Park Street;
- (i) Henry Street, between Independence Square North and Park Street;
- (j) Queen Street, between Frederick Street and Richmond Street; and
- (k) Park Street, between St. Vincent Street and Abercromby Street.

(2) Notwithstanding subclause (1), vehicles belonging to the Police Service and the Defence Force may park on the eastern side of Edward Street, between Queen Street and Sackville Street.

4. From 10.00 a.m. to 5.00 p.m., the driver of a motor vehicle is prohibited from driving on the following roads:

- (a) St. Vincent Street, between Duke Street and Queen Street;
- (b) Hart Street;
- (c) Abercromby Street, between Independence Square North and Park Street; and
- (d) Knox Street, between Abercromby Street and Frederick Street.

5. Notwithstanding clauses 3 and 4, vehicular traffic and parking are permitted for vehicles bearing green, blue or purple event-specific windscreen permission labels.

6. From 10.00 a.m. to 5.00 p.m., the driver of a motor vehicle proceeding north along Abercromby Street shall turn west onto Queen Street.

Taxi routes

7. A taxi driver plying—

- (a) the St. Ann's route from Hart Street, shall operate from the southern side of Queen Street, between Frederick Street and Abercromby Street; and
- (b) the St. James route from Hart Street, shall operate from the northern side of Independence Square North, between Frederick Street and Henry Street.

8. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
