Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

# THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (CARNIVAL) ORDER, 2023

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Carnival) Order, 2023.
  - 2. In this Order— Interpretation

"Carnival Monday" means Monday 20th February, 2023; and

"Carnival Tuesday" means Tuesday 21st February, 2023.

3. This Order has effect from 17th February, 2023 to Carnival Duration Tuesday, inclusive.

### PART I

### PORT-OF-SPAIN

## Division 1—Vehicular Traffic and Parking

- 4. (1) On Carnival Monday, between the hours of 2.00 a.m. and Vehicular 10.00 p.m., vehicular traffic and parking are prohibited on the following parking roads and on all roads lying within and bounded by them:
  - (a) Duke Street, between Piccadilly Street and Wrightson Road;
  - (b) Park Street, between Flament Street and Piccadilly Street;
  - (c) Stone Street, between Park Street and Flament Street;
  - (d) Flament Street, between Stone Street and Wrightson Road;
  - (e) Independence Square North, between Wrightson Road and Piccadilly Street;
  - (f) Independence Square South, between Wrightson Road and Piccadilly Street;
  - (g) St. Joseph Road, between Piccadilly Street and Vieira Street;

- (h) Charlotte Street, between Queen's Park East and Queen's Park West and South Quay;
- (i) Nelson Street;
- (j) Duncan Street;
- (k) Fraser Street;
- (1) Richmond Street;
- (m) St. Vincent Street, between Keate Street and South Quay;

- (o) Frederick Street, between Independence Square North and Queen's Park West;
- (p) Henry Street, between South Quay and Gordon Street;
- (q) Sackville Street;
- (r) Broadway;
- (s) Queen Janelle Commissiong Street;
- (t) South Quay, between Nelson Street and Wrightson Road;
- (u) New Street, between Dundonald Street and Charlotte Street;
- (v) Belmont Circular Road, between Charlotte Street and the entrance to the Port-of-Spain General Hospital;
- (w) Phillip Street;
- (x) Tragarete Road, between Damien Street and St. Vincent Street;
- (y) Piccadilly Street, between Park Street and South Quay;
- (z) Gray Street, between St. Clair Avenue and Tragarete Road;
- (aa) Alexandra Street, between St. Clair Avenue and Tragarete Road;
- (bb) Elizabeth Street, between St. Clair Avenue and Tragarete Road; and
- (cc) St. Clair Avenue, between Elizabeth Street and Western Main Road.
- (2) Notwithstanding subclause (1)(t) the driver of a taxi plying the San Fernando, Chaguanas, Sangre Grande, Arima or Tunapuna to Port-of-Spain route may park in accordance with clauses 13 and 15.

- (3) On Carnival Monday, between the hours of 2.00 a.m. and 10.00 p.m., and on Carnival Tuesday, between the hours of 6.00 a.m. and 10.00 p.m., vehicular traffic and parking are prohibited on the following roads lying within and bounded by the specified roads:
  - (a) Queen's Park West, from Queen's Park East to Prada Street;
  - (b) Sweet Briar Road;
  - (c) Gray Street, between St. Clair Avenue and Tragarete Road;
  - (d) Alexandra Street, between Serpentine Road and Tragarete Road:

- (gg) Hayes Street, between Serpentine Road and Maraval Parkway;
- (hh) Flood Street, between Serpentine Road and Alexandra Street;
- (ii) Flood Street, between Mary Street and Maraval Road; and
- (jj) Pole Carew Street.

## Parking prohibited

- 5. (1) On Carnival Monday, between the hours of 2.00 a.m. and 10.00 p.m., parking is prohibited on the following roads:
  - (a) Oxford Street, between Observatory Street and Dundonald Street; and
  - (b) Stone Street.
- (2) On Carnival Monday, between the hours of 2.00 a.m. and 10.00 p.m., and on Carnival Tuesday, between the hours of 6.00 a.m. and 10.00 p.m., parking is prohibited on the following roads:
  - (a) Circular Road, between St. Clair Roundabout and Jerningham Avenue;
  - (b) Maraval Road, between Circular Road and Tragarete Road;
  - (c) St. Clair Avenue;
  - (d) Damian Street;

- 6. (1) On Carnival Monday, between the hours of 2.00 a.m. and One-way 10.00 p.m., vehicular traffic shall proceed along Stone Street, between <sup>traffic</sup> Wrightson Road and Park Street, in a southerly direction only.
- (2) On Carnival Monday, between the hours of 2.00 a.m. and 10.00 p.m., and on Carnival Tuesday, between the hours of 6.00 a.m. and 10.00 p.m., vehicular traffic shall proceed along Prada Street, between Maraval Road and Wainwright Street, in a westerly direction only.

Two-way traffic

- 7. (1) During the period commencing on Friday 17th February, 2023 and ending on Carnival Tuesday, vehicular traffic may proceed in both directions—
  - (a) around the Queen's Park Savannah, between Casual Corner and Jerningham Avenue;
  - (b) on Observatory Street, between Quarry Street and Belmont Circular Road;
  - (c) on Belmont Circular Road, between Observatory Street and the entrance to the Port-of-Spain General Hospital;
  - (d) on Oxford Street, between Observatory Street and Charlotte Street:
  - (e) on Gaston Johnson Street;
  - (f) on Panka Street, between Gaston Johnson Street and Lucknow Street:
  - (g) on Lucknow Street; and
  - (h) on Rapsey Street, between Maraval Road and Wainright Street.
- (2) On Carnival Tuesday, vehicular traffic may proceed in both a northerly and southerly direction on the northbound carriageway of Maraval Parkway, between Belle Smythe Street and Wrightson Road.

Route for  $from \stackrel{-}{Belmont}$ and St. Ann's

8. Vehicular traffic proceeding to St. James from Belmont or proceeding to St. Ann's shall proceed west along Circular Road, north onto Maraval St. James Road, west onto Rapsey Street and then onto Barbados Road.

Route for General Hospital

- 9. Vehicular traffic proceeding to the Port-of-Spain General vehicles on an Hospital on an emergency shall proceed along one of the following Port-of-Spain routes and shall leave the Port-of-Spain General Hospital along the reverse of the route:
  - (a) north along Henry Street, east onto New Street and then into the Port-of-Spain General Hospital;
  - (b) north along Edward Street, east onto New Street and then into the Port-of-Spain General Hospital;
  - (c) north along French Street onto Maraval Road, east onto Warner Street, south onto Cipriani Boulevard, east onto Melville Street, south onto Dundonald Street, east onto New Street and then into the Port-of-Spain General Hospital;

- (d) north along Long Circular Road, south onto Maraval Road, east onto Warner Street, south onto Cipriani Boulevard, east onto Melville Street, south onto Dundonald Street, east onto New Street and then into the Port-of-Spain General Hospital;
- (e) west along Lady Young Road, south onto Queen's Park East, then onto Charlotte Street and then into the Port-of-Spain General Hospital via the Maternity Ward Entrance; or
- (f) east along Sackville Street, north onto Edward Street, east onto New Street and then into the Port-of-Spain General Hospital.

## Division 2—Taxi and Maxi-taxi Stands

- 10. This Division has effect from 2.00 a.m. on Carnival Monday to <sub>Duration</sub> Carnival Tuesday.
- 11. The driver of a taxi assigned to the taxi stand on Chacon Long Circular/Street, between Independence Square South and South Quay, shall Wrightson operate from the northern side of Dock Road, between Wrightson Road taxi stand and the entrance to the Port Authority.
- 12. The driver of a taxi assigned to the taxi stand on South Quay, Diego Martin/between Broadway and Abercromby Street shall operate from the Petit Valley/St. James southern side of Dock Road, between Wrightson Road and the entrance taxi stand to the Port Authority.
- 13. The driver of a taxi assigned to the taxi stand on the southern "On-call"/side of Independence Square North, between Abercromby Street and Ice House St. Vincent Street and on the eastern and western sides of Cipriani Circle, between Independence Square North and Independence Square South shall operate on Charles Street, from Scott Bushe Street, facing west.
- 14. The driver of a taxi assigned to the San Fernando and the San Fernando Chaguanas taxi stand on Broadway, between South Quay and Chaguanas taxi stand Independence Square South shall operate on the northern side of South Quay, between George Street and Nelson Street, facing east.
- 15. The driver of a taxi assigned to the Morvant/Trou-Macaque Morvant/Trou taxi stand shall operate on the southern side of the east bound Macaque taxi stand carriageway Off the Old St. Joseph Road, east of Piccadilly Street, facing east.

Tunapuna/ Arima/ Sangre Grande taxi stand

16. The driver of a taxi assigned to the taxi stand on Henry Street, between Independence Square South and South Quay shall operate on the southern side of South Quay, between Nelson Street and George Street.

Belmont taxi stand

17. The driver of a taxi assigned to the taxi stand on Queen Street and Charlotte Street shall operate from Observatory Street and Charlotte Street, respectively.

Maraval taxi stand

18. The driver of a taxi assigned to the taxi stand on Duke Street and Charlotte Street shall operate from Belmont Circular Road and Belleau Road, respectively.

Route 1 maxi-taxis

19. The driver of a Route 1 maxi-taxi shall enter the maxi-taxi stand on South Quay by way of the Beetham Highway and exit by way of the southern side of South Quay, forty metres east of the Beetham Highway.

## Division 3—Parade of Bands

Bands entering and leaving Queen's Park Šavannah Competition Centre

- 20. (1) A band proceeding to the Queen's Park Savannah Competition Centre shall proceed along Charlotte Street, west onto Queen's Park West and then north into the Queen's Park Savannah.
- (2) A band exiting the Queen's Park Savannah shall proceed south onto Victoria Avenue and then east onto Tragarete Road.

Bands entering Adam Smith Square Competition Centre

21. A band proceeding to the Adam Smith Square Competition Centre shall proceed along Tragarete Road, south onto Pole Carew Street and then east along Ariapita Avenue.

entering and leaving from South Quay Competition

22. A band proceeding to the South Quay Competition Centre shall proceed along St. Vincent Street, east onto South Quay, north onto Charlotte Street, west onto Queen's Park West and then onto the South Quay Competition Centre.

Bands entering Soca Drome

23. A band proceeding to the Soca Drome, at Hasley Crawford Stadium, shall proceed along Damian Street, south onto Taylor Street, west onto Ariapita Avenue, south onto Maraval Parkway on the south bound carriageway only and then into the Hasley Crawford Stadium via Castro Gate.

Bands entering and leaving Piccadilly Street Competition Centre

- 24. (1) A band proceeding to the Piccadilly Street Competition Centre shall proceed east along Independence Square South and then north onto Piccadilly Street.
- (2) A band exiting the Piccadilly Street Competition Centre shall proceed north along Piccadilly Street, west onto Park Street, north along Charlotte Street and then west onto Queen's Park West to enter the Queen's Park Savannah.

25. Vehicular traffic shall enter the Queen's Park Savannah at the Entry of following locations:

the Queen's Park Savannah

- (a) Queen's Park East, near St. Ann's Roundabout; or
- (b) Queen's Park West (Casual 2)

  26. Vehicular traffic shall exit the Queen's Park Savannah at Exit of vehicles from the Queen's Park Savannah Queen's Park West (Casual Corner).
- 27. (1) A person attending the parade of bands at the DRAG may Parking of park his vehicle in the Queen's Park Savannah during the period vehicles in the Queen's Park commencing three hours prior to the start of the parade of bands and Savannah ending three hours after the closure of the parade of bands.
- (2) Parking in the Queen's Park Savannah shall be in accordance with the directions of the police officer on duty.

### Division 4—Traffic Light Signal

28. Traffic light signals shall not be in operation from 2.00 a.m. on Operation of Carnival Monday to Carnival Tuesday.

## Division 2—Emergency Provisions

Evacuation routes for individulas

- 32. In the event of an emergency, masqueraders and spectators shall be directed to evacuate the area via any of the following evacuation routes:
  - (a) north along Bournes Road to Kathleen Street, west along Kathleen Street to George Cabral Street to proceed either south or north along George Cabral Street;
  - (b) west along Western Main Road to George Cabral Street, and then continue to proceed either west along Western Main Road or north onto George Cabral Street;
  - (c) east along Western Main Road to Roxy Roundabout, and then continue to proceed east along Tragarete Road, south along Damien Street onto Mucurapo Road or east along St. Clair Avenue; or
  - (d) south along Ethel Street onto Mucurapo Road to proceed either east or west along Mucurapo Road.

- 33. (1) In the event of an emergency, vehicular traffic shall access Emergency the St. James Medical Facility by proceeding along Long Circular Road, route for between Western Main Road and Delhi Street, west onto Delhi Street, traffic continuing onto Kathleen Street and south onto Western Main Road.
- (2) Vehicular traffic shall exit the St. James Medical Facility by proceeding along the reverse of the route set out in subclause (1).
- (3) Vehicular traffic may also proceed onto Audrey Jeffers Highway, onto Western Main Road, onto George Cabral Road, onto Kathleen Street, onto Barbados Road, onto Saddle Road and then to the Queen's Park Savannah.
- (4) During the period of the road closures vehicular traffic may utilize Mucurapo Road and Patna Street.
  - 34. The following locations are designated muster points:

  - (b) taxis heading west, on the corner of Coronation Street and Western Main Road.
- (2) On Carnival Monday, between the hours of 4.00 a.m. and 10.00 a.m., an individual can access a taxi on Mucurapo Road and Audrey Jeffers Highway.
  - 36. From Roxy Roundabout—

- (a) west along Western Main Road, St James;
- (b) south along Mathura Street;
- (c) east along Mucurapo Street;
- (d) south along Taylor Street;

  - (b) Carnival Monday, between the hours of 4.00 a.m. and 10.00 a.m.;
  - (c) Carnival Monday, from 6.00 p.m.;
  - (d) Carnival Tuesday, between the hours of 10.00 a.m. and 2.00 p.m.; and
  - (e) Carnival Tuesday, from 4.00 p.m.

## PART IV

## Santa Cruz

- 39. Vehicular traffic and parking are prohibited on Cantaro Road Parking and Extension, between Bass Street and Stollmeyer Street—
  - (a) on Carnival Monday, between the hours of 4.00 a.m. and prohibited 10.00 a.m.;
  - (b) on Carnival Monday, from 2.00 p.m.; and
  - (c) on Carnival Tuesday from 4.00 p.m.

Without prejudice to any other liability incurred by the Removal and commission of a violation, vehicles found parked in contravention of this  $^{\rm impounding}_{\rm of\ vehicles}$  Order may be removed by the police and impounded and dealt with in unlawfully accordance with section 108(1)(b) of the Motor Vehicles and Road  $^{\rm parked}$  Traffic Act.
