THE APPROPRIATION (FINANCIAL YEAR 2025) BILL, 2024

**Explanatory Note**

(This note forms no part of the Bill but is intended only to indicate its general purport)

The Bill seeks to provide for the service of Trinidad and Tobago for the financial year ending September 30, 2025 by authorising the issue from the Consolidated Fund of the sum of Forty Nine Thousand, Ninety Seven Million, Thirty Five Thousand, Five Hundred and Twenty Five Dollars (\$49,097,035,525).

ENACTED by the Parliament of Trinidad and Tobago as Enactment  
follows:

**1.** This Act may be cited as the Short title  
(Financial Year 2025) Act, 2024.

Issue from the  
Consolidated Fund  
authorised

**2.** (1) The issue from the Consolidated Fund of the sum of Forty Nine Thousand, Ninety Seven Million, Thirty Five Thousand, Five Hundred and Twenty Five Dollars (\$49,097,035,525) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2025, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of Forty Nine Thousand, Ninety Seven Million, Thirty Five Thousand, Five Hundred and Twenty Five Dollars (\$49,097,035,525) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2025.

Commencement

**3.** This Act is deemed to have come into force on the 1st day of October, 2024.
