Function and structure of the Regulated Industries Commission

#### Mission statement:

The Mission Statement of the Regulated Industries Commission is to:

To ensure promotion of the highest quality of utility services at fair and reasonable rates while building a credible regulatory regime that responds adequately to stakeholders' concerns and also ensure fairness, transparency and equity in the provision of utility services throughout the country.

The RIC is a statutory body established by Act No. 26 of 1998 ("the RIC Act") to regulate and monitor the operations of the service providers named in the RIC Act. The RIC replaced the Public Utilities Commission ("PUC") whose jurisdiction was issued under the PUC Act Chap 34:01, which was repealed under the RIC Act. The service providers that presently fall under the purview of the RIC Act include:

- The Water and Sewerage Authority ("WASA")
- The Trinidad and Tobago Electricity Commission ("T&TEC")
- The Power Generation Company of Trinidad and Tobago ("PowerGen")
- Contour Global Trinity Power Limited (formerly Trinity Power Limited and InnCogen Limited).

The Commission as duly constituted consists of a Chairman, Deputy Chairman and at least three (3) other members. The total composition of the Commission shall not consist of less than five (5) or more than seven (7) members, appointed by the President for a maximum of five (5) years at any one time. The RIC Act also provides for an Executive Director.

The RIC Act makes provision for the establishment of Consumer Services Committees, members of which are appointed by the Minister and will consist of a Chairman, a representative nominated by the Tobago House of Assembly and three (3) other members who will serve as consumer advocates. Such committees will advise the Commission on matters related to quality of service delivered and ensure that complaints procedures of service providers produce speedy resolutions for consumers. They may also be required to contribute to deliberations of the Commission where rates and licence conditions come under review.

- The role of the Commission under the RIC Act includes: - Making Recommendations to the Minister on the award of
- licences.
- Prescribing and monitoring standards of services.
- Establishing the principles on which tariffs will be based and conducti periodic reviews of rates.
  Conducting studies of efficiency and economy of operation and
- performance by service providers. - Investigating consumer complaints and facilitating relief in
- respect of rates, billing and unsatisfactory service. - Facilitating competition among service providers, where
- desirable.
- Collection of Licence fees.

The functions of the Commission are discharged by a complement of thirty – nine (39) members of staff of the Commission. Staff serves as a support arm of the Commission by functioning in furtherance to the mandate of the Commission. See organizational structure of the Commission. The office of the Commission is located on the 1<sup>st</sup> and 2<sup>sd</sup> Floors of the Commission's offices situate at #88 Queen Janelle Commissiong Street, Port-of-Spain.



#### Notes to the Abridged Financial Statements 31 December 2023 (Expressed in Trinidad and Tobago Dollars)

1 Incorporation and activities

CUNA Caribbean Insurance Society Limited ('the Company') is incorporated in Trinidad and Tobago and is registered under the Insurance Act, 2018 to carry on long-term insurance business in Trinida and Tobago. Its registered office is located at 11 Queen's Park East, Port of Spain. The Company is a wholly-owned subsidiary of CUNA Caribbean Holdings St. Lucia Limited, a Company incorporated in St. Lucia. CUNA Mutual Holding Company ('the Ultimate Parent') is incorporated in the United States of America.

#### 2 Basis of preparation

The abridged financial statements are prepared in accordance with the Guideline on the Publication of Abridged Financial Statements issued by the Central Bank of Trinidad and Tobago. The abridged financial statements are extracted directly from the Company's audited financial statements which are prepared in accordance with IFRS Accounting Standards. The abridged statement of financial position as at 31 December 2023 and the statements of comprehensive income, changes in equity and cash flows for the year then ended were exactly re-produced from the Company's audited financial statements. However, the disclosures within the abridged financial statements were limited to disclosures deemed material and necessary to present a true and fair view of the Company's performance.

The abridged financial statements have been prepared in accordance with the accounting policies set out in the respective notes of the audited financial statements consistently applied from period to period. All new and amended accounting standards and the interpretations that are mandatory for the periods disclosed and which are relevant to the Company, have been adopted.

The abridged financial statements have been prepared on a going concern basis

The full financial statements can be accessed at the Company's office during normal business hours.

#### 3 Functional and presentation currency

Items in these abridged financial statements are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). These financial statements are presented in Trinidad and Tobago dollars, which is the Company's functional currency.

#### 4 IFRS 17 Insurance Contracts

Effective 1 January 2023, IFRS 17 replaced IFRS 4 Insurance Contracts, materially changing the recognition and measurement of insurance contracts and the corresponding presentation and disclosures in the Company's financial statements.

#### (a) Change in Accounting Policies

Refer to Note 3 (a) 1 .15 of the Company's audited financial statements for the year ended 31 December 2023 for details of the Company's accounting policies under IFRS 17.

#### (b) Transition Approach

In accordance with the transition requirements of IFRS 17, the Company has restated its financial statements, and is therefore presenting:

- Within the summarised statement of financial position, an opening balance sheet as at 1 January 2022, the date of transition to IFRS 17. Differences between the carrying value of assets and liabilities previously recorded and those under IFRS 17 were recorded in equity.
- Summarised statements of financial position, income, comprehensive income, cash flows, and changes in equity as at and for the periods ended 31 December 2023 and 31 December 2022, in compliance with IFRS 17.

While retrospective application is required, if full retrospective application to a group of contracts is impractical, the modified retrospective or fair value methods may be used. The Company therefore applied the fair value approach to its Pension Plus businesses that were in issue as at 1 January 2022 and prior, and the full retrospective approach thereafter. For all other portfolios, the full retrospective approach was used for all relevant periods.

The initial application adjustments arise principally from:

- The introduction of the Contractual Service Margin (CSM).
   This is a new liability that represents future unearned profits on long-term insurance contracts written
- The measurement of the Risk Adjustment This is a concept in IFRS 17 that is similar to the Margins for Adverse Deviation that was previously estimated under IFRS 4. IFRS 17 does however introduce some specific considerations in the calculation and application of this item.
- The determination of Discount Rates IFRS 17 introduced some changes in how discount rates are determined, primarily removing from consideration the characteristics of the assets which support the related insurance liabilities.
- Other measurement changes
   This includes changes to the level at which contracts are aggregated for measurement
   purposes and how contract boundaries are defined.
- Presentation changes Several assets and liabilities experienced no change to their measurement but have been moved to other areas of the financial statements, including:
  - Premiums receivable and Policy loans These amounts were previously reported in loans and receivables and have now been reclassified to insurance contract liabilities/assets as they are insurance contract related.
     Deposits with reinsurers – These amounts were previously reported in loans and
