#### **Function and Structure of the South-West Regional Health Authority**

The SWRHA is in the business of promoting wellness and providing compassionate, cost-effective customer-focused health care to the people of the South-West region of the Island of Trinidad within the guidelines of national policy.

The SWRHA is a statutory body, which was established on May 20, 1994 in accordance with the Regional Health Authorities Act Chapter 29:05 (RHA Act) of the Laws of the Republic of Trinidad and Tobago. Pursuant to the RHA Act, SWRHA is managed by a Board of Directors and is required to exercise its powers and functions in accordance with such specific or general directions as may be given to it by the Minister of Health. 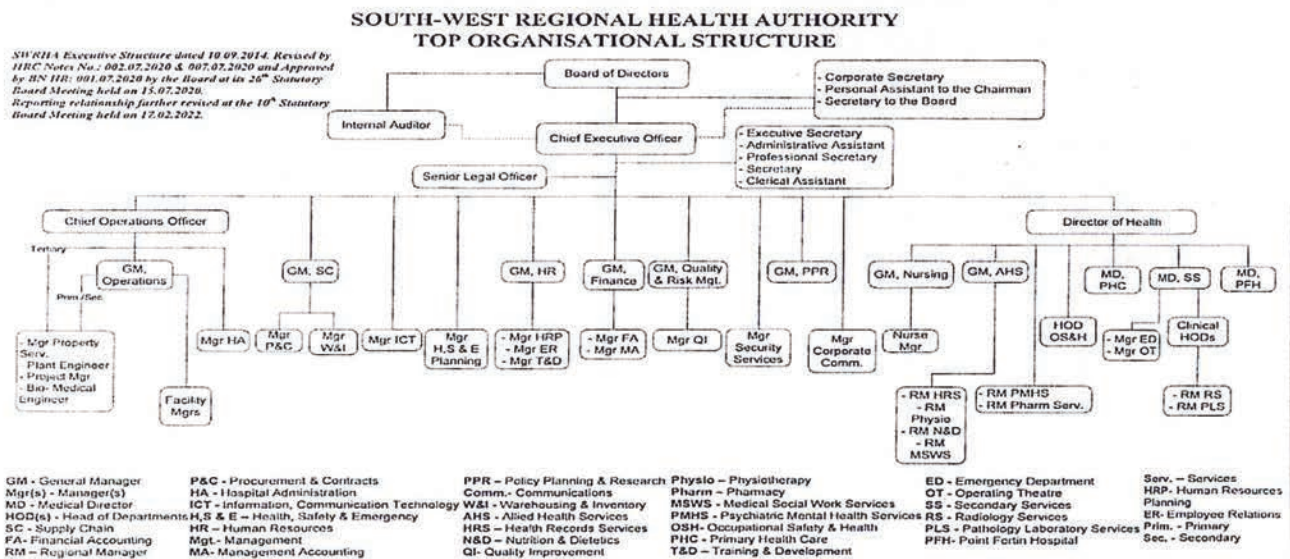

### Responding to the Request

The SWRHA is required to furnish copies of documents only when they are in our possession.

Please note that some documents created prior to the commencement of the Freedom of Information Act 1999 may have already been destroyed. The granting of a request for such documents may therefore be impossible. Various laws, regulations and manuals specify the time periods for keeping records before they will be destroyed, for example, the Exchequer and Audit Act, Chapter 69:01.
