DELEGATION OF POWERS TO THE STANDING COMMITTEE OF THE BOARD

Dated this 28th day of DECEMBER, 2023

WHEREAS:

1. Under section 8 of the Securities Act, Chapter 83:02 of the Laws of the Republic of Trinidad and Tobago (“the Act”) the Commission may, by Order, delegate any of its responsibilities, powers or functions except the power to make By-Laws and to hear appeals under section 160 of the Act, to any Commissioner.
2. Under section 16(1) of the Act, the Board may, by resolution, appoint a committee of the Commission to submit recommendations with respect to the performance of any function of the Commission under the Act.
3. Pursuant to section 16(1) of the Act, by resolution dated 18th December 2023 Commissioner Dillon Teelucksingh was appointed as the Standing Committee of the Board.

AND WHEREAS:

4. Pursuant to section 8(1) of the Act, the Board now considers it appropriate and expedient for the purpose of the administration of the Act to delegate certain of its responsibilities, powers, and functions to:

DELEGATION OF THE POWERS TO STANDING COMMITTEE OF THE BOARD—CONTINUED

- a. Commissioner Dillon Teelucksingh, Commissioner of the Board to act as the Standing Committee; and

for the purpose of making recommendations on the performance of the Commission's powers and functions under sections 150, 151 and 159 (2) of the Act.

IT IS HEREBY ORDERED THAT:

5. Commissioner Dillon Teelucksingh shall be appointed as the Standing Committee of the Board of Commissioners;
6. The Standing Committee shall be given delegated authority to execute the following powers granted to the Commission:
 - a. To authorize the conduct of investigations pursuant to section 150 of the Act. In particular, the Standing Committee may act for the Commission to appoint investigators to:
 - i. Ascertain whether any person has contravened, is contravening or is about to contravene the Act; or
 - ii. To assist with the administration of the securities laws or the regulation and supervision of the securities industry in another jurisdiction.
 - b. Authorize requests for information in accordance with section 151 of the Act which allows the Commission to obtain information and documents from any person, if the Commission considers it necessary or desirable for the purposes of performing or exercising its functions, powers or duties under the Act, or to assist with the administration of securities laws or the regulation and supervision of the securities industry in another jurisdiction.
 - c. In accordance with section 159(2) of the Act, to:
 - i. Issue a subpoena or other request or summons requiring a person to attend a hearing to testify to all matters regarding the hearing, and to produce all records regarding the hearing, that are in his possession or under his control, whether they are located in or outside of Trinidad and Tobago; and
 - ii. Require a person to give evidence orally or in writing on oath or affirmation as it thinks necessary.


