


Background

Whereas:

- (ii) The parties may not have clearly identified the issue or point of law in the related appeal;
or
- (iii) The parties may have differing views as to the extent to which the appeal so litigated or determined by the Court may have a bearing on other appeals.

This Practice Direction now provides as follows:

1. Parties are to file a statement identifying the issue or point of law by which they will be guided or agree to be bound in a specified appeal (s) when so directed by the Court.
2. If the parties disagree as to the issue or point of law in the appeal so identified from which the anticipated guidance is expected, each party is at liberty to file separate statements.
3. Any such statement is to follow the format attached to this Practice Direction as Appendix A (which may be modified or adapted as necessary) and forms part of this Practice Direction.
4. Any such statement is without prejudice to the right of appeal pursuant to the *Tax Appeal Board Act and Rules*, Chap. 4:50 of the Laws of Trinidad and Tobago of the substantive decision(s) so identified.
5. This Practice Direction is to be referred to as Practice Direction No. 12 of 2024 and comes into force with effect from 1st June 2024.
