ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Labour Day Celebrations—Fyzabad) Order, 2024.

2. This Order shall have effect between the hours of 6.00 a.m. and Duration midnight on Wednesday 19th June, 2024.

3. (1) Parking is prohibited between the hours of 6.00 a.m. and ${}_{\rm Parking midnight-}$

- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
- (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between Fyzabad-Oropouche Road and Mon Desir-Delhi Road;
- (g) Fyzabad-Oropouche Road, between Fyzabad Junction and Avocat Junction;
- (h) Gowers Well Road, between Fyzabad-Guapo Road and Patterson Street;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road;
- (*j*) Uriah Butler Avenue;
- (k) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street.

(2) Parking is prohibited between the hours of 6.00 a.m. and 10.00 p.m. on Fyzabad-Oropouche Road, from Avocat Junction to Charlie King Junction.

(3) Parking is prohibited between the hours of 6.00 a.m. and 2.00 p.m. on—

- (a) Siparia Old Road, between Avocat Junction and Samlal Trace; and
- (b) Fyzabad-Oropouche Road, between Avocat Junction and Jebodhsingh Street.

Vehicular traffic prohibited 4. (1) A driver shall not drive his motor vehicle between the hours of 6:00 a.m. and midnight along Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.

(2) A driver shall not drive his motor vehicle between the hours of 6.00 a.m. and 10.00 p.m. on Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.

Traffic route

- 5. A driver entering—
 - (a) Fyzabad from Oropouche, shall—
 - (i) turn left at Avocat Junction, then onto Siparia Old Road, then onto Fyzabad-Guapo Road to the Fyzabad Composite School;
 - (ii) turn left at Ralph Narine Trace, then left onto St. John Trace, then left onto Avocat-Siparia Old Road at the Avocat Vedic School, then onto Fyzabad-Guapo Road to the Fyzabad Composite School; or
 - (iii) right onto Berridge Trace, left onto Mon Desir Road, then left onto Delhi Road and then onto Gowers Well Road;
 - (b) Oropouche from Fyzabad, shall proceed along Fyzabad-Guapo Road, turn left onto Siparia Old Road, right onto St. John trace, then left onto Ralph Narine Trace to Oropouche Main Road and then turn right at Ralph Narine Trace Junction;
 - (c) San Fernando or Point Fortin from Fyzabad, shall proceed west along Delhi Road then north-west onto Mon Desir Delhi Road, then onto the Solomon Hochoy Highway Extension; and
 - (d) Siparia from Fyzabad or Forest Reserve, shall proceed in an easterly direction onto Uriah Butler Avenue and then onto Fyzabad-Guapo Road.

6. Traffic shall proceed in both directions along the Fyzabad-Guapo Two-way Main Road, between Lum Tack Hill and Bhola's Hardware.

7. In an emergency, a driver entering—

Emergency route

- (a) San Fernando from Fyzabad shall proceed along Delhi Road onto Lutchman Drive, then onto Sewlal Trace via Fyzabad Main Road in Pepper Village; or
- (b) Siparia from Fyzabad shall proceed along Delhi Road, onto John Jules Trace, then onto Gowers Well Road, then turn right onto Guapo Road, then turn—
 - $(i) \ left onto Uriah Butler Avenue; or$
 - (ii) onto Road No. 34 and then proceed to Siparia Road.

8. Without prejudice to any other liability incurred by the Removal and commission of a traffic violation, vehicles found parked in contravention $\frac{\text{impounding}}{\text{of vehicles}}$ of this Order may be removed by the police and impounded and dealt unlawfully with in accordance with section 108(1)(b) of the Motor Vehicles and $\frac{\text{parked}}{\text{Chap. 48:50}}$ Road Traffic Act.
