THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(SIPARIA BOROUGH J'OUVERT CELEBRATIONS 2024)  
ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Siparia Borough J'ouvert Celebrations 2024) Order, 2024. Citation

2. This Order shall have effect between the hours of 3.00 a.m. and 11.00 a.m. on Saturday 22nd June, 2024. Duration

3. A driver shall not park his motor vehicle on—

Parking  
prohibited

- (a) Daisy Voison Street, between Mary Street and San Fernando-Siparia-Erin Road;
- (b) Coora Road, between Mary Street and San Fernando-Siparia-Erin Road;
- (c) La Pastora Street, between Mary Street and San Fernando-Siparia-Erin Road;
- (d) Allies Street, between Bermudez Street and San Fernando-Siparia-Erin Road;
- (e) George Street, between Coora Road and La Pastora Street;
- (f) Edward Street, between Mary Street and San Fernando-Siparia-Erin Road;
- (g) San Fernando-Siparia-Erin Road, between Siparia Old Road and Grell Street;
- (h) Mary Street, between Allies Street and La Pastora Street;
- (i) Grell Street, between Gamble Street and San Fernando-Siparia-Erin Road;
- (j) Villabera Street;
- (k) Catherine Drive; and
- (l) Well Road, between Catherine Drive and San Fernando-Siparia-Erin Road.

Vehicular  
traffic  
prohibited

4. A driver shall not drive his motor vehicle along—
- (a) Daisy Voison Street, between Mary Street and San Fernando-Siparia-Erin Road;
  - (b) Coora Road, between Mary Street and San Fernando-Siparia-Erin Road;
  - (c) La Pastora Street, between Mary Street and San Fernando-Siparia-Erin Road;
  - (d) Allies Street, between Bermudez Street and San Fernando-Siparia-Erin Road;
  - (e) George Street, between Coora Road and La Pastora Street;
  - (f) Edward Street, between Mary Street and San Fernando-Siparia-Erin Road; and
  - (g) San Fernando-Siparia-Erin Road, between Siparia Old Road and Grell Street.

Alternative  
Routes

5. A driver proceeding from—
- (a) Erin shall proceed, north unto Siparia Old Road, east unto Gambal Street, south unto Grell Street, then east unto the Siparia-Erin Road to Penal or San Fernando;
  - (b) Erin shall proceed, north unto Siparia Old Road, east onto Park Street, south unto Grell Street, then east unto the Siparia-Erin Road to Penal or San Fernando;
  - (c) Fyzabad shall proceed, east unto Gambal Street, then south unto Grell Street to Penal or San Fernando;
  - (d) Fyzabad shall proceed, west on Villabera Street, then onto Catherine Drive, south onto Well Road, then west onto San Fernando-Siparia-Erin Road to Santa Flora;
  - (e) Penal shall proceed, north unto Grell Street, turn left onto Park Street, then onto Siparia Old Road to Siparia; and
  - (f) Penal shall proceed, north unto Grell Street, turn left onto Gambal Street, then onto Siparia Old Road to Siparia.

Relocation of  
taxi stands

6. The following taxi stands are relocated as follows:
- (a) the San Fernando taxi stand, to the Daisy Voison Hub;

(b) the Penal taxi stand, to the Daisy Voison Hub;

(c) the Erin/Santa Flora taxi stand, to the entrance of the Siparia Market; and

(d) the Fyzabad taxi stand, to the Daisy Voison Hub.

7. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
