MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(REPUBLIC OF TRINIDAD AND TOBAGO SIXTY-SECOND
ANNIVERSARY OF INDEPENDENCE CELEBRATIONS)
ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary ^{Citation} Provisions) (Republic of Trinidad and Tobago Sixty-Second Anniversary of Independence Celebrations) Order, 2024.

2. This Order shall have effect between 6.00 a.m. on Saturday ^{Duration} 31st August, 2024 to 1.00 a.m. on Sunday 1st September, 2024.

3. A driver of a motor vehicle shall not park his motor vehicle— ^{Parking prohibited}

(a) from 6.00 a.m. to 12.00 noon on Saturday 31st August, 2024
on the following roads:

- (i) Queen's Park West, between Queen's Park East and Cipriani Boulevard;
- (ii) Chancery Lane, between Gordon Street and Queen's Park West;
- (iii) Dere Street;
- (iv) Albion Street;
- (v) Dundonald Street, between Queen's Park West and New Street;
- (vi) New Street, between Dundonald Street and Abercromby Street;
- (vii) Gordon Street;
- (viii) Frederick Street, between Queen's Park West and Park Street;
- (ix) Park Street, between Frederick Street and St. Vincent Street;

- (x) Western Main Road, between its junction with Tragarete Road and its junction with Long Circular Road; and
- (xi) Tragarete Road;
- (b) from 6.00 a.m. to 3.00 p.m. on Saturday 31st August, 2024, on Long Circular Road, between Western Main Road and Patna Street; and
- (c) from 12.00 noon on Saturday 31st August, 2024 to 1.00 a.m. on Sunday 1st September, 2024 on the following roads:
 - (i) Queen's Park West, from Chancery Lane to St. Clair Avenue;
 - (ii) Maraval Road, from St. Clair Avenue to Saddle Road;
 - (iii) Circular Road, from Saddle Road to St. Ann's Road;
 - (iv) Queen's Park East, from St. Ann's Roundabout to Queen's Park West; and
 - (v) Charlotte Street, from Queen's Park West to New Street.

Vehicular

4. The driver of a motor vehicle shall not drive his motor vehicle—

- (a) from 7.00 a.m. to 10.00 a.m. on Saturday 31st August, 2024 on the following roads:
 - (i) Queen's Park West, between Queen's Park East and Chancery Lane;
 - (ii) Keate Street;
 - (iii) Frederick Street, between Queen's Park West and Park Street;
 - (iv) Albion Street, between Chancery Lane and Victoria Street;
 - (v) Pembroke Street, between Keate Street and Gordon Street; and
 - (vi) Chancery Lane, between Gordon Street and Queen's Park West;
- (b) from 7.00 a.m. to 11.00 a.m. on Saturday 31st August, 2024, on Park Street, between Henry Street and Edward Street; and

(c) from 7.00 a.m. to 12.00 noon on Saturday 31st August, 2024
on the following roads:

(i) Tragarete Road; and

(ii) Western Main Road, between Damian Street and
Lucknow Street.

5. From 7.00 a.m. to 12.00 noon on Saturday 31st August, 2024, the Traffic diverted
driver of a motor vehicle driving—

(a) along Queen's Park East, shall continue south along
Charlotte Street and turn west onto Gordon Street or
Oxford Street;

(b) north along Henry Street, shall turn west onto Gordon
Street;

(c) north along Pembroke Street, shall turn west onto Gordon
Street; and

(d) north along Edward Street, shall turn west onto Gordon
Street.

6. The driver of a motor vehicle may park his motor vehicle Parking in
in the Queen's Park Savannah from 6.00 a.m. to 11.00 a.m. on Saturday Queen's Park
31st August, 2024, as directed by a police officer on duty. Savannah

7. Without prejudice to any other liability incurred by the Removal and
commission of a traffic violation, vehicles found parked in contravention impounding of
of this Order may be removed by the police and impounded and dealt vehicles
with in accordance with section 108(1)(b) of the Motor Vehicles and unlawfully
Road Traffic Act. parked
