## ORDER

Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (TOBAGO CARNIVAL) ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Tobago Carnival) Order, 2024.

## Scarborough

2. This Order shall have effect on—

- (a) Saturday 26th October, 2024 between the hours of 3.00 a.m. and 10.00 a.m. and 5.00 p.m to 12.00 midnight; and
- (b) Sunday 27th October, 2024 between the hours of 1.00 a.m. to 2.00 a.m. and from 10.00 a.m. to 12.00 midnight.

#### 3. Vehicular traffic is prohibited—

- (a) on Milford Road, Scarborough and the roundabout in the prohibited vicinity of Crusoe Bypass Road to Scarborough Waterfront; and
- (b) along the Claude Noel Highway, from Orange Hill traffic lights to Wilson Road traffic lights.

#### 4. Parking is prohibited—

- (a) in the Market Square Car Park;
- (b) in the Old First Citizens Bank Car Park situated on Carrington Street;
- (c) on Wilson Road, Scarborough between Carrington Street and the Claude Noel Highway;
- (d) on the Claude Noel Highway, in the vicinity of Wilson Road;
- (e) on Orange Hill Road in the vicinity of Yat's Marketing and Milford Road; and
- (f) on Gardenside Street and North Side Connector Road.

Parking prohibited in specific areas

Vehicular traffic and parking prohibited

- 5. Vehicular traffic and parking are prohibited—
  - (a) on the Claude Noel Highway, from Orange Hill traffic lights to Wilson Road traffic lights;
  - (b) on Orange Hill Road, from NP Quik Shoppe to Richard's Hardware;
  - (c) on Mt. Marie Junction;
  - (d) at the Light and Life highway entrance;
  - (e) in front of the entrance to Penny Savers;
  - (f) on Dutch Fort Junction and Royal Castle;
  - (g) on Post Office Street;
  - (h) on Market Square;
  - (i) at the Waterfront Pharmacy, Scarborough;
  - (j) at the Port entrance, Dutch Fort Junction;
  - (k) on Sangsters Hill;
  - (l) on Scarborough Esplanade;
  - (m) on TLH compound;
  - (n) at the Taxi Corporation;
  - (o) at the I love Tobago sign;
  - (p) on Smith Field Road junction;
  - (q) on Breeze Hall Road;
  - (r) on Darrel Spring Connector Road;
  - (s) on Gardenside and Wilson Road;
  - (t) on Carrington Street; and
  - (u) on Milford Road.
- Taxi stands 6. The temporary relocation of taxi stands are as follows:
  - (a) West End Taxis plying the Scarborough route shall park on Pump Mill Junction and Wilson Road facing North; and
  - (b) Taxis plying the Windward and Northern district routes shall park on the northern shoulder of the Claude Noel Highway, east of the Claude Noel Highway and Plymouth Road intersection, facing East.

- 7. The parade route for Carnival in Scarborough for-
  - (a) J'ouvert and Parade of the Bands shall commence at Comfort Inn along Crusoe Bypass, proceeding north along Orange Hill Road until the traffic lights, then east along the Claude Noel Highway, until the Wilson Road traffic lights, then turn right onto Wilson Road, proceeding south along Wilson Road, then turn right, proceeding west along Milford Road continuing along Milford Road, and then turn left onto Milford Road Extension, proceeding west until the Shaw Park Cultural Complex Car Park; and
  - (b) Night Mas and Traditional Mas shall commence at Milford Road Scarborough, proceeding east onto Carrington Street, then north along Gardenside street, then turn left onto Post Office Street, then turn left onto Wilson Road Street until the Scarborough Port.

#### GENERAL

- 8. In case of an emergency, all emergency vehicles shall proceed— Emergency
  - (a) from the west, along the Claude Noel Highway, turn north Scarborough at the Lambeau/Signal Hill Road and Claude Noel Highway General Hospital intersection, onto the Signal Hill/Lambeau Connector Road, then east onto the Signal Hill Main Road and southeast onto the Old Government Farm Road to the Scarborough General Hospital;
  - (b) from the east, along the Claude Noel Highway, turn north at the Plymouth Road and Wilson Road intersection, then west onto Spring Garden Trace, south along Spring Garden Road, west onto Spring Garden Extension, north onto Orange Hill Road, cross the bridge onto Signal Hill Main Road, and then turn southeast onto the Old Government Farm Road to the Scarborough General Hospital.

9. Notwithstanding clauses 3 and 4, a person driving a vehicle Access to may traverse prohibited routes at the discretion of and in accordance prohibited with the directions of a police officer who is on duty.

10. Without prejudice to any other liability incurred by the Removal and commission of a traffic violation, vehicles found parked in contravention impounding of vehicles of this Order may be removed by a member of the Police Service and unlawfully impounded and dealt with in accordance with section 108(1) of the parked Motor Vehicles and Road Traffic Act, Chap. 48:50.
