# THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SAN FERNANDO CITY MONTH) ORDER, 2024

### PART I

#### Preliminary

1. This Order may be cited as the Traffic Restriction (Temporary <sub>Citation</sub> Provisions) (San Fernando City Month) Order, 2024.

2. This Order has effect on Saturday 16th November, 2024, from- Duration

(a) 3.00 a.m. to 11.00 a.m., for J'Ouvert celebrations; and

(b) 5.00 p.m. to 11.00 p.m., for "Pan and Powder" celebrations.

#### PART II

# San Fernando

# Division 1-Vehicular traffic and Parking

3. (1) A person is prohibited from driving and parking a motor Vehicular traffic and parking a motor Vehicular traffic and parking.

- (a) Royal Road;
- (b) Coffee Street;
- (c) Cipero Street;
- (d) Carib Street;
- (e) Rienzi-Kirton Highway;
- (f) Todd Street, between Rienzi-Kirton Highway and Westwood Street; and
- (g) Point-a-Pierre Road, between St. James Street and High Street.

(2) A person driving north along Cipero Street, across the Cross Crossing Interchange, is prohibited from proceeding north from the Rienzi-Kirton Highway intersection.

4. A person is prohibited from parking a motor vehicle from 3.00 a.m. Parking prohibited to 11.00 a.m. on-(a) Navet Road, between the San Fernando By-Pass and Coffee Street; (b) Kelshall Street, between Royal Road and Hobson Street; and (c) Hobson Street, between Kelshall Street and Marryat Street. 5. Notwithstanding clause 3, a person driving a vehicle shall Traffic routes proceed-(a) west along Naparima-Mayaro Road, turn south and proceed around the roundabout, then turn north onto San Fernando By-Pass and then turn west onto St. Joseph Road; (b) north-west along Navet Road and turn south onto Bertrand Street: (c) south along Point-a-Pierre Road and turn west onto St. James Street; and (d) north along Cipero Street from the Cross Crossing Interchange, turn south-east at the Rienzi-Kirton Highway and continue south-east onto Cipero Road. 6. A person who operates a maxi-taxi for hire plying the Maxi-taxi stand San Fernando to Princes Town Route shall park on Royal Road and relocation proceed in a north-easterly direction from Mon Repos Street. 7. A person who operates a taxi for hire plying-Taxi stand relocation (a) the San Fernando to Ste. Madeleine, Palmyra and Diamond Route, shall park on Royal Road; and (b) the San Fernando to Princes Town Route, shall park on Royal Road, and proceed in a north-easterly direction from Mon Repos Street. Division 2—The Parade

Band route 8. (1) Bands shall assemble for J'Ouvert celebrations on Point-a-Pierre Road in the vicinity of the Oilfields Workers' Trade Union Building and then proceed north-east along Point-a-Pierre Road to the parade route. (2) The parade route for J'Ouvert celebrations shall commence from the corner of Circular Road and Point-a-Pierre Road, proceed east and then south along Circular Road, turn west onto Royal Road, continue south along Royal Road, turn west onto Coffee Street, continue west along Coffee Street, turn south onto Cipero Street and continue south along Cipero Street, to end north of the Cross Crossing Interchange at the intersection of Cipero Street and the Rienzi-Kirton Highway.

(3) The parade route for "Pan and Powder" celebrations shall commence from the corner of Navet Road and Coffee Street, proceed west along Coffee Street, turn south onto Cipero Street and continue south along Cipero Street, to end at Skinner Park First Class Grounds.

#### PART III

#### GENERAL

9. In case of an emergency, all vehicles proceeding to the Emergency San Fernando General Hospital—

General

- (a) from Naparima-Mayaro Road and environs, shall turn south Hospital and proceed around the roundabout, then turn north onto San Fernando By-Pass, west onto St. Joseph Road, south-west onto London Street, west onto Circular Road, continue south-west along Circular Road onto Point-a-Pierre Road, west onto Chacon Street, west onto Queen Street and south onto Lady Hailes Avenue to the San Fernando General Hospital; and
- (b) from Skinner Park and environs, shall turn west onto the Rienzi-Kirton Highway and continue north-west onto Lady Hailes Avenue to the San Fernando General Hospital.
