ORDER

Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SAN FERNANDO CITY MONTH) (MILITARY PARADE) ORDER, 2024

PART I

PRELIMINARY

1. This Order may be cited as the Traffic Restriction (Temporary _{Citation} Provisions) (San Fernando City Month) (Military Parade) Order, 2024.

2. This Order has effect on Saturday 23rd November, 2024, from Duration 5.00 a.m. to 12.00 noon.

PART II

San Fernando

Division 1—Vehicular traffic and Parking

3. (1) A person is prohibited from driving and parking a motor Vehicular traffic and parking

parking prohibited

- (a) Coffee Street, between Cipero Street and Point-a-Pierre Road;
- (b) Cipero Street;
- (c) Harris Promenade;
- (d) Chancery Lane;
- (e) Lower High Street, between the Queen Street and Hollis Street intersection and the Hollis Street and Chancery Lane intersection;
- (f) Queen Street;
- (g) King Street;

- (h) that part of the waterfront area to which the public are granted access, from King Street and proceeding south along Queen Street, commonly known as "King's Wharf"; and
- (i) Lady Hailes Avenue, between Queen Street and Steve Achaiba Street.

(2) A person driving north along Cipero Street is prohibited from proceeding north along Cipero Street from the intersection of the Cross Crossing Interchange and Rienzi-Kirton Highway.

- Traffic routes 4. Notwithstanding clause 3, a person driving a motor vehicle shall proceed—
 - (a) north along Cipero Street and from the Cross Crossing Interchange, turn—
 - (i) north-west onto Rienzi-Kirton Highway; or
 - (ii) south-east onto the Rienzi-Kirton Highway and continue south-east onto Cipero Road;
 - (b) south along Point-a-Pierre Road and turn west onto St. James Street; and
 - (c) south along Dr. Rupert Indar Drive, continue onto Hollis Street and turn north-east onto High Street.

Taxi stand relocation 5. A person who operates a taxi for hire plying the San Fernando to Port-of-Spain Route shall park on San Fernando Street, proceed east along San Fernando Street and turn north onto Point-a-Pierre Road.

Division 2—The Parade

Parade route 6. The parade route shall commence on Cipero Street, in the vicinity of Skinner Park, proceed north along Cipero Street, turn west onto Coffee Street, continue north and then north-west along Coffee Street, then from the intersection of Point-a-Pierre Road, La Pique Road and Harris Promenade, turn west along Harris Promenade, turn north onto Chancery Lane, turn north-west onto Lower High Street, turn west onto Hollis Avenue, continue west onto Queen Street, turn south along Queen Street and proceed along King's Wharf and then turn south-west along Queen Street, to end at the intersection of Queen Street and Lady Hailes Avenue.

PART III

General

- 7. In case of an emergency, all vehicular traffic shall—
 (a) from the Cross Crossing Interchange, proceed west along the Rienzi-Kirton Highway, turn south onto Todd Street and continue south onto Lady Hailes Avenue; and
 - (b) proceed north along the Rienzi-Kirton Highway, turn west onto Ruth Avenue Extension and Steve Achaiba Street and then north onto Lady Hailes Avenue,

to the San Fernando General Hospital.

8. Without prejudice to any other liability incurred by the Removal and commission of a traffic violation, vehicles found parked in contravention $_{\rm of \ vehicles}^{\rm impounding}$ of this Order may be removed by the Police and impounded and dealt $_{\rm unlawfully}^{\rm unlawfully}$ with in accordance with section 108(1)(b) of the Motor Vehicles and $_{\rm Chap.\ 48:50}^{\rm parked}$ Road Traffic Act.
