THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(PORT-OF-SPAIN AND ST. JAMES CHILDREN'S CARNIVAL
PARADE OF BANDS) ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Port-of-Spain and St. James Children's Carnival Parade of Bands) Order, 2024. Citation

2. This Order shall have effect in— Duration

- (a) Port-of-Spain from 6.00 a.m. to 4.00 p.m. on Saturday 10th February, 2024; and
- (b) St. James from 9.00 a.m. to 7.00 p.m. on Sunday 4th February, 2024.

PART I

PORT-OF-SPAIN

3. Vehicular traffic and parking are prohibited on— Vehicular traffic and parking prohibited
- (a) Knox Street, between St. Vincent Street and Frederick Street;
 - (b) Hart Street, between Frederick Street and St. Vincent Street;
 - (c) Abercromby Street, between South Quay and Independence Square North;
 - (d) Independence Square North, between Henry Street and Edward Street;
 - (e) Independence Square South, between Henry Street and Edward Street;
 - (f) South Quay, between Broadway and Wrightson Road;
 - (g) Broadway, between Beetham Highway and Independence Square South;

- (h) Queen Street, between Henry Street and Edward Street;
- (i) Duke Street, between Henry Street and Pembroke Street;
- (j) Park Street, between Henry Street and Pembroke Street;
- (k) Oxford Street, between Henry Street and Pembroke Street;
- (l) New Street, between Henry Street and Pembroke Street;
- (m) Gordon Street, between Henry Street and Pembroke Street;
- (n) Keate Street, between Charlotte Street and Pembroke Street;
- (o) Henry Street, between New Street and Gordon Street; and
- (p) Queen's Park West, between Queen's Park East and Chancery Lane.

Parking
prohibited

4. Parking is prohibited on—

- (a) Chancery Lane;
- (b) Dundonald Street, between Queen's Park West and New Street; and
- (c) Albion Street, between Chancery Lane and Stanmore Avenue.

One-way
traffic only

5. Vehicular traffic shall proceed in a westerly direction only along—

- (a) Keate Street, between Pembroke Street and Chancery Lane;
- (b) Gordon Street, between Pembroke Street and St. Vincent Street; and
- (c) Albion Street.

Taxi stands

6. Taxis plying for hire shall operate as follows:

- (a) St. Ann's taxi drivers shall ply for hire on the southern side of Queen Street, between St. Vincent Street and Edward Street;
- (b) St. James taxi drivers shall ply for hire on the western side of Edward Street, between Independence Square North and Queen Street;
- (c) Ice House/Broadway/Marine Square taxi drivers shall ply for hire on the northern and southern sides of Independence Square North, between Edward Street and Wrightson Road;

- (d) San Fernando taxi drivers shall ply for hire from the northern side of South Quay, between George Street and Duncan Street, facing east;
- (e) Chaguanas taxi drivers shall ply for hire from the southern side of South Quay, between George Street and Duncan Street, facing west;
- (f) Long Circular/Wrightson Road taxi drivers shall ply for hire on the southern side of Independence Square South between St. Vincent Street and Wrightson Road, facing west; and
- (g) Diego Martin/Petit Valley taxi drivers shall ply for hire on the northern side of Independence Square South, between St. Vincent Street and Wrightson Road, facing west.

7. Carnival bands shall proceed in the vicinity of Central Bank, Band route south along St. Vincent Street, onto South Quay, east along South Quay onto Broadway, north along Broadway onto Frederick Street to enter the Queen's Park Savannah via the entrance opposite Frederick Street.

PART II

ST. JAMES

8. Vehicular traffic is prohibited— Vehicular traffic prohibited
- (a) on Western Main Road, from Long Circular Road to George Cabral Street;
 - (b) on the westbound lane from Nelson Mandela Park, St Clair Avenue, along Western Main Road to Long Circular Road; and
 - (c) on the westbound lanes of Western Main Road, from Roxy Roundabout to Benares Street.

9. Vehicular traffic shall proceed in both directions along the eastbound lane of Western Main Road from Long Circular Road to Roxy Roundabout. Two-way traffic only

10. Vehicular traffic is prohibited from entering Western Main Road from Long Circular Road to George Cabral Street. No entry to vehicular traffic

11. Carnival Bands shall proceed along Western Main Road from Long Circular Road to George Cabral Street and the judging point shall be on Western Main Road in front of St. James Amphitheatre. Band Route

12. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
