ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (FUNERAL SERVICE OF LISA MORRIS-JULIAN M.P.) ORDER, 2024

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Funeral Service of Lisa Morris-Julian M.P.) Order, 2024.
- **2.** This Order has effect from midnight on Wednesday 1st January, Duration 2025 to 3.00 p.m. on Thursday, 2nd January, 2025.
- **3.** (1) A person shall not park a motor vehicle on the following Vehicular roads, from midnight on 1st January, 2025 to 3.00 p.m. on 2nd January, parking prohibited
 - (a) Queen Street, between Broadway Street and De Gannes Street;
 - (b) Woodford Street, between Hollis Avenue and De Gannes Street;
 - (c) St. Joseph Street, between Sanchez Street and De Gannes Street;
 - (d) Hollis Avenue, between Industry Street to Lord Kitchener Street;
 - (e) King Street, between Sorzano Street and De Gannes Street;
 - (f) Sorzano Street, between King Street and Prince Street;
 - (g) De Gannes Street, between King Street and Queen Street;
 - (h) Church Street, between King Street and Queen Street;
 - (i) Broadway Street, between Queen Street and Woodford Street; and
 - (j) Sanchez Street, between Queen Street and King Street.

- (2) A person shall not drive a motor vehicle on the following roads from 10.00 a.m. to 3.00 p.m. on Thursday, 2nd January, 2025:
 - (a) King Street, between De Gannes Street and Sorzano Street; and
 - (b) Sanchez Street, between Mausica Church Street and King Street.
- (3) A person driving a motor vehicle from 10.00 a.m. to 3.00 p.m. shall proceed along the following routes:
 - (a) north on Woodford Street and turn right onto Sorzano Street;
 - (b) west on Sanchez Street and turn left onto Queen Street;
 - (c) north on King Street and turn right onto De Gannes Street;
 - (d) south on St. Joseph Street and turn left or right onto De Gannes Street;
 - (e) east on De Gannes Street and turn right onto Queen Street;
 - (f) west on De Gannes Street and turn left onto King Street;
 - (g) from Mausica Church Street, east on Sanchez Street and turn right on King Street; and
 - (h) east on Sorzano Street and turn right onto St. Joseph Street.
- (4) Notwithstanding subclauses (1) and (2) and subject to the conditions in subclause (5), a person may drive a motor vehicle from 6.00 a.m. to 3.00 p.m. on Thursday, 2nd January, 2025, where that person—
 - (a) has written authorisation to park or drive the motor vehicle by the Commissioner of Police;
 - (b) has an amber drop-off pass displayed on the motor vehicle; and
 - (c) resides on any of the streets referred to in subclause (2).
 - (5) The conditions referred to in subclause (4) are as follows:
 - (a) "an amber drop-off pass" referred to in subclause 4(b)—
 - (i) is a pass issued by the Minister of Foreign and CARICOM Affairs; and
 - (ii) permits access to the inner zone for drop-off purposes only; and

- (b) for the purposes of subclause (4)(c), a resident is required to provide verification of his address in order to have vehicular access to the inner zone.
- (6) For the purposes of subclause (5), "inner zone" means the area enclosed within the following boundaries:
 - (a) to the north, by De Gannes Street, between King Street and Queen Street;
 - (b) to the south, by Sorzano Street, between King Street and Queen Street;
 - (c) to the east, by Queen Street, between De Gannes Street and Sorzano Street; and
 - (d) to the west, by King Street, between Sorzano and De Gannes Street.
- **4.** A person who operates a taxi for hire plying the Calvary Hill Taxi Taxi stand Stand shall park on Sorzano Street between Queen Street and relocation Prince Street from 6.00 a.m. to 3.00 p.m. on Thursday, 2nd January, 2025.
- **5.** Without prejudice to any other liability incurred by the Removal and commission of a traffic violation, motor vehicles found parked in $^{\text{impounding}}_{\text{of vehicles}}$ contravention of this Order may be removed by the Police and impounded unlawfully and dealt with in accordance with section 108(1)(b) of the Motor Vehicles $^{\text{parked}}_{\text{Chap. }48:50}$ and Road Traffic Act.
