ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA KI MAI CELEBRATIONS) ORDER, 2024

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Ki Mai Celebrations) Order, 2024.
- 2. This Order shall commence on Wednesday 27th March, 2024 at Duration 2.00 p.m. and expire on Friday 29th March, 2024 at 3.00 p.m.
- 3. Vehicular traffic and parking are prohibited between the Vehicular hours of 12.00 p.m. on Wednesday 27th March, 2024 and 3.00 p.m. on traffic and parking Friday 29th March, 2024 on—
 - (a) George Street, between Coora Road and La Pastora Street;
 - (b) Mary Street, between Coora Road and La Pastora Street;
 - (c) Station Street, between Mary Street and Victoria Street;
 - (d) Edward Street, between Mary Street and San Fernando-Siparia-Erin Road;
 - (e) Cemetery Street, between La Pastora Street and Clara Gregory Street;
 - (f) La Pastora Street, between Victoria Street and San Fernando-Siparia-Erin Road;
 - (g) Coora Road, between San Fernando-Siparia-Erin Road and Victoria Street; and
 - (h) Victoria Street, between Coora Road and La Pastora Street.
- 4. Parking is prohibited between the hours of $2.00~\rm p.m.$ on Parking Thursday 28th March, 2024 and $3.00~\rm p.m.$ on Friday 29th March, 2024 on— prohibited
 - (a) De Gannes Lane;
 - (b) Siparia Old Road, between Potters Lane and San Fernando-Siparia-Erin Road;
 - (c) Grell Street; and
 - (d) Gambal Street.

Traffic routes

- 5. Between the hours of 2.00 p.m. on Thursday 28th March, 2024, and 2.00 p.m. on Friday 29th March, 2024, vehicular traffic approaching Siparia from—
 - (a) Erin, proceeding in an easterly direction along the San Fernando-Siparia-Erin Road shall turn north onto Siparia Old Road, east onto Gambal Street, south onto Grell Street and east onto the San Fernando-Siparia-Erin Road;
 - (b) Fyzabad, proceeding in a southerly direction along the Siparia Old Road, shall turn east onto De Gannes Lane, south onto Potters Lane and back onto the Siparia Old Road; and
 - (c) Penal, proceeding in a westerly direction along the San Fernando-Siparia-Erin Road, shall turn north onto Grell Street, onto Gambal Street and onto the Siparia Old Road.

Taxi stands

- 6. Between the hours of 2.00 p.m. on Thursday 28th March, 2024, and 2.00 p.m. on Friday 29th March, 2024, taxi stands shall operate as follows:
 - (a) the Erin Taxi Stand shall be relocated to the entrance of the Siparia Market; and
 - (b) the Penal Taxi Stand shall be relocated to the western side of Bermudez Street at the junction of the San Fernando-Siparia-Erin Road.

Removal and impounding of vehicles unlawfully parked Chap. 48:50 7. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
