ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(SIPARIA BOROUGH DAY PARADE) ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Borough Day Parade) Order, 2024.

2. This Order shall have effect between the hours of 6.00 a.m. to Duration 1.00 p.m. on Friday 7th June, 2024.

3. A driver shall not park his motor vehicle on—

Parking  
prohibited

- (a) San Fernando-Siparia-Erin Road, between Bermudez Trace and Railway Road;
- (b) Allies Street, between San Fernando-Siparia-Erin Road and Bermudez Trace;
- (c) Daisy Voison Street, between Mary Street and San Fernando-Siparia-Erin Road;
- (d) Siparia Old Road, between San Fernando-Siparia-Erin Road and Park Street;
- (e) George Street, between Allies Street and Daisy Voison Street;
- (f) Coora Road, between George Street and San Fernando-Siparia-Erin Road; and
- (g) Edward Street, between George Street and San Fernando-Siparia-Erin Road.

4. A driver shall not drive his motor vehicle on—

Vehicular  
traffic  
prohibited

- (a) Daisy Voison Street;
- (b) Coora Road, between Victoria Street and San Fernando-Siparia-Erin Road;
- (c) La Pastora Street;
- (d) Allies Street, between Mary Street and Victoria Street;

- (e) George Street, between Coora Road and La Pastora Street;
- (f) Victoria Street;
- (g) Park Street;
- (h) Grell Street, between San Fernando-Siparia-Erin Road and Gambal Street;
- (i) Well Road, between Catherine Drive and San Fernando-Siparia-Erin Road;
- (j) Catherine Drive;
- (k) Villabera Street;
- (l) Railway Road; and
- (m) Station Street.

Traffic route

5. A driver proceeding from—

- (a) Santa Flora to exit Siparia, shall proceed south onto Railway Road, in a north-easterly direction onto Station Street, east onto Victoria Street, north unto Allies Street, then east onto Bermudez Trace to San Fernando-Siparia-Erin Road; and
- (b) Penal towards Siparia, shall proceed north onto Grell Street, turn left onto Gambal Street, onto Siparia Old Road, then north towards Fyzabad.

Relocation of  
taxi stands

6. The following taxi stands are relocated as follows:

- (a) the San Fernando taxi stand, to the Daisy Voison Hub;
- (b) the Penal taxi stand, to Daisy Voison Hub;
- (c) the Erin/Santa Flora taxi stand, to the corner of San Fernando-Siparia-Erin Road and Railway Road; and
- (d) the Fyzabad taxi stand, to the Daisy Voison Hub.

Removal and  
impounding  
of vehicles

7. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
