A further issue from the Consolidated Fund in the sum of three thousand, one hundred and forty three million, nine hundred and eighty three thousand, seven hundred and sixty one dollars (\$3,143,983,761) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending September 30, 2025 and appropriated in respect of the Heads of Expenditure set out in the Schedule to this Act.


