APPOINTMENT OF A CUSTOMS AREA (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Riad Juman, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(3) of the said Act, do hereby appoint the place specified in the schedule hereto, to be a Customs Area, on behalf of Messrs. Amerijet Caribbean Express Limited, of Piarco International Airport, South Side, Golden Grove Road, Piarco in which imported goods may be deposited in a building designated by the Comptroller of Customs and Excise pending entry for home consumption or export as indicated and described in the Schedule hereunto.

SCHEDULE

An area comprising approximately 1,133.7 square metres, situated on the JSL Speedpak Services Limited Compound, Piarco International Airport, South Side, Golden Grove Road, Piarco. The area is bounded on the north by other lands of the Airports Authority of Trinidad and Tobago (AATT) and leased to Amerijet Caribbean Express Limited, on the south lands of the AATT which are leased to JSL Speedpak Services Limited, on the east by unoccupied lands of the AATT and on the west by a Road Reserve. The area is enclosed with chainlink fencing.
