APPOINTMENT OF A PRIVATE WAREHOUSE

Customs Act, Chap 78:01

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Riad Juman Acting Comptroller of Customs and Excise, acting under the provisions of Section 263(2) of the said Act, do hereby appoint the place, specified in the schedule hereunder, to be a Private Warehouse, on behalf of Messrs.
