Minimum Experience and Training Requirements:

Considerable (4 to 8 years) experience in processing Meteorological data including experience (18 months to 4 years) in a supervisory capacity as may have been gained as a Meteorologist; and training as evidenced by a recognised degree in Meteorology, Mathematics or Physics, supplemented by a post graduate training in Computer Science, Systems Administration or Systems Engineering; or any equivalent combination of experience and training.

Distinguishing Features of Work:

An employee in this class is responsible for planning, organising and directing the Information Technology activities of the Meteorological Services Division. Work involves formulating the Information Technology Strategic Plan of the Division, providing technical advice on the application of Information Technology, reviewing and developing hardware and software specifications, writing source programmes for tasks that cannot be performed by off-the-shelf application programmes and supervising the work of the Maintenance and Repair Section. Work is performed with considerable initiative and independent judgement within the framework of established polices but is subject to review by a senior professional through discussions and reports for adherence to policy, standards set by the World Meteorological Organisation (WMO) and efficiency and effectiveness.
